BOOK PUBLISHING AGREEMENT

MEMORANDUM OF AGREEMENT made this 29th day of March in the year 2023 between

hereinafter referred to as the AUTHOR(S) / EDITOR(S) and NAROSA PUBLISHING HOUSE PVT. LTD., New Delhi, hereinafter referred to as the PUBLISHERS with respect to a work tentatively titled:

INFORMATICS AND AI FOR HEALTHCARE

The AUTHOR(S) / EDITOR(S) and PUBLISHERS agree to collaborate in the publication of the work in book or electronic form and all subsequent revisions as hereinafter provided, on the following terms:

- 1. Publication Rights: The Author(s) / Editor(s) shall prepare and supply the manuscript / work for publication comprising about ____ pages in print with ____ figures and ____ tables by ____ and hereby grant(s) and assigns to the Publishers the full and exclusive rights on the terms specified in this agreement, to print, publish, convert and or digitize or publish in electronic form and sell the work and all subsequent revisions and adaptations thereof throughout the world in all languages, in hard and / or soft cover and in text, reprint, electronic and other editions and to dispose of all subsidiary rights thereto in all languages.
- **2. Copyright:** The Copyright of the work shall vest in the Publishers as per Law i.e. during the Authors life time and sixty years thereafter.
- 3. Manuscript: The Author(s) / Editor(s) agree to provide a Hard Copy of the final manuscript in Camera Ready Format fit for reproduction with pages formatted as per the Publisher's guidelines. The print area of the text should be 4.75" or 12 cm (in width) of all pages and 7" or 18 cm (in height / depth) of the chapter opening page and 8" or 20 cm (in height / depth) of all other pages inclusive of the folio line / headers / page numbers etc. The manuscript would be printed on A4 size paper (only one side) using 1200 DPI Laser Printer. All Black and White photographs will be provided in originals (no photocopies or scanned images). A soft copy of the manuscript (CD / Floppy) along with a hard copy will be preferred. The book will be published in the Trim Size 6.25" x 9.5". The cost of preparation of the typescript and accompanying material shall be borne by the Author(s) / Editor(s). In case the manuscript and the illustrations are to be prepared by the Publisher, such Costs will be debited to the Author(s) / Editor(s) account and shall be borne by the Author(s)/Editor(s). In addition if there are any coloured illustrations / photographs to be printed, the cost of processing, printing etc. in colour will be borne by the Author(s) / Editor(s).

- 4. Correction of Proofs and Index Preparation: The Author(s) / Editor(s) undertake diligently to check and correct printer's proofs sent to them for this purpose by the Publishers and to return them to the Publishers within 15 days of the receipt of the proofs. If the Author(s) / Editor(s) fail(s) or is / are unable to check proofs as just stipulated, the Publishers shall be free to arrange for such checking by a person in the Publishers judgment competent to do so, and the cost of this arrangement will be debited to the royalty account of the work, as the first charge, also, if the Author(s) / Editor(s) fails or is unable to prepare the index, the Publishers shall be free to arrange for its preparation and the expenses incurred will be debited to the royalty account of the Author(s) / Editor(s).
- 5. Author's Corrections: Should the Author(s) / Editor(s) make or cause to be made any additions/revisions in text or any alterations in type, illustrations or plates, which are not corrections of typographical errors after receiving proofs, the cost of such alterations shall be charged to, and paid for, by the Author(s) / Editor(s). The Publishers may, at their discretion, agree to debit such charges to the royalty account of the Author(s) / Editor(s).
- **6.** Sale of the Works: The Publishers shall have exclusive control of the sale and of the terms of the sale of the work
- 7. **Typescript Revisions:** The Publishers shall have the right to make such editorial changes in the typescript as they deem desirable and necessary, but the Author(s) / Editor(s) shall be given the opportunity to see such changes.
- **8. Delivery of Work:** If the Author(s) / Editor(s) fails to supply the full and final manuscript along with the agreed illustrations by the date mentioned for this purpose in Clause (1) of this agreement, the Publishers shall have the option, any time after this date, unilaterally, to declare this agreement cancelled after giving the Author(s) / Editor(s) ninety days notice in writing to provide the necessary material, unless the Publishers have meanwhile agreed in writing to an extension of the period to submitting the materials. In the absence of such a written notice, this agreement will continue to be fully effective and for this period the Publishers will be deemed to have agreed to an extension of the date for the delivery of the material till the date of the expiry of any notice the Publishers may subsequently serve on the Author(s) / Editor(s).

9. Royalty:

- (a) The Publishers agree to pay the Author(s) / Editor(s) royalty of 10% (ten percent) of the NET Indian selling price on copies sold. In case the Royalty amount falls below Rs. 3000.00 on both the domestic and international sales (as provided in 9(b) below) in any given year, the same will be carried over to the next year(s) till the amount becomes Rs.3000.00 or more.
- (b) Against overseas sales, any Royalty amounts received from Co-Publishers on their Net receipts will be shared equally between the Author(s) / Editor(s) (50%) and the Publishers (50%). The Co-Publisher will establish its own list price and trade terms.
- (c) The price paid by the Co-Publisher against purchase of printed sheets / bound copies (less discount) for production of their edition, shall be excluded from sharing with the Author(s) / Editor(s).
- (d) On all international sales made directly by the Publisher or distribution arrangements including copublishing concluded by the Publisher, not involving payment of royalties by the Distributor / Co-Publisher, the Royalty to the Author(s) / Editor(s) will be 10% (Ten Percent) of the actual amounts received by the Publisher or the net Indian selling price, whichever is higher irrespective of the selling price established by the Distributor / Co-Publisher.
- (e) In case of two or more Author(s) / Editor(s), the royalty division between the Author(s) / Editor(s) shall be:

- (f) The Publishers shall have the sole right to publish, or grant license for all editions in print or electronic form or to permit others to publish such selection from the work, as they think proper to benefit its sale. Any revenue received by the Publishers for the publication of such selections or the sale of serial, translation, radio and television recordings, book clubs, or other rights, shall be divided equally as in para 9(b) in lieu of royalties between the parties hereto.
- (g) If the Publishers themselves undertake the publication of translation or abridgements or adaptations of the work in English or in any other language(s), this agreement will govern, as far as the context which permit, such publication by Publishers. Accounting and payment to the Author(s) / Editor(s) will be governed by Clause 9(a) and 9(b), subject to the deduction of expenses incurred by the Publishers in having the said translations, abridgements or adaptations prepared.

- (h) The Royalty payment shall be calculated on the actual sales of the work as on 31st March and statement of account alongwith the cheque for the amounts due shall be provided to the Author(s) / Editor(s) by 30th September each year.
- (i) **Nomination:** The Author(s) / Editor(s) nominate the following persons(s) to receive the Royalties in the event of the death of the Editor(s) / Author(s):

- 10. Sale of Surplus Stock: The Publishers shall be entitled to sell surplus stock of the work as remainder at the best price such remainder stock shall fetch only after two years have lapsed since first publication of the work. If the price of the remainder stock is more than the cost of production, the Publishers shall pay the Author(s) / Editor(s) 10% of the amount realized by such sale, and this shall be in lieu of royalties. In case such stocks are sold below production cost, no royalties will be payable.
- 11. Publication: The Publishers shall proceed to publish the work in such manner and styles and in such editions and at such catalogue retail price as they deem appropriate and shall use their best efforts to promote the sale of the work. The Publishers shall also make such licensing or other arrangements, as they deem appropriate for printing, publications in print and / or electronic form for the sale of the work.
- 12. Author(s) / Editor(s) Copies: The Publishers agree to give the Author(s) / Editor(s) on publication a total of five copies of the first edition and a total of two copies of each new edition. In case of two or more Author(s) / Editor(s) the number of copies just stipulated shall be shared between the Author(s) / Editor(s). The Author(s) / Editor(s) would be entitled to purchase additional copies from the Publishers at a discount of 25% of the list price. These copies will not be for resale.
- 13. Competing Works: The Author(s) / Editor(s) agrees that he will not, during the continuance of this agreement, without the written consent of the Publishers, write, print, or publish, or cause to be written, printed or published, any other edition of the work, revised, enlarged, abridged or otherwise, or any book of a character that might interfere with or injure the sale of the work.
- **14. Revised Edition:** The Author(s) / Editor(s) and the Publisher agree to discuss the publication of a revised edition to determine if a revised edition is desirable. Should the Author(s) / Editor(s) be unable or unwilling to perform such revision within a reasonable length of time or be deceased at the time at which it is determined that such revision is desirable, the Publishers shall have the right to arrange for the preparation of a revised typescript. In such case, the reviser shall be compensated by a share of the royalty on the sale of such revised edition or by a fee paid by the Publishers and charged as a first charge against royalty and other income accruing to the Author(s) / Editor(s) on the sale of such revised edition.
- **15. Solution** / **Teachers Manual:** The Author(s) / Editor(s) agree to prepare a Solutions Manual for the problems and exercise in the book and provide the same with the manuscript to help the sale of the book. As this material will be distributed 'free' by the Publishers, the Author(s) / Editor(s) will not be entitled to any honorarium for preparing this material. In case, however, the Author(s) / Editor(s) express their inability to prepare the same or do not do so within a reasonable time, the Publisher would be free to have it prepared elsewhere and debit all costs incurred in this regard to the Author(s) / Editor(s) royalty account as a first charge.

16. Warranty:

- (a) The Author(s) / Editor(s) warrant that the work is original except for such excerpts from copyrighted works as may be included with the permission of the copyright owners thereof, that it contains no libelous statements, that it contains nothing unlawful, and does not infringe upon any copyright, trade mark, patent statutory right or proprietary right of the others.
- (b) The Author(s) / Editor(s) hereby assure the Publishers that no statement of fifty or more words or illustrations or tables shall appear in the work from other copyright material without prior written permission having been obtained by the Author(s) / Editor(s) from the copyright holders. The Author(s) / Editor(s) shall also provide the Publishers a copy of each written permission obtained.

- (c) The Author(s) / Editor(s) hereby agree to indemnify the Publishers against any costs, expenses and damages arising from any breach of this warranty including the cost of printing / publishing the book and the cost of any and all copies that may have to be withdrawn from sale or destroyed.
- **17. Assignments:** This agreement may be assigned by either party, but only as a whole, and no part of the respective interests of either party may be assigned without the written consent of the other party. Notwithstanding any such assignments, this agreement shall be binding on the parties hereto, their heirs, successors, assigns and personal representatives.
- **18. Protection of Copyright:** The Publishers shall be free to take, on the Author(s) / Editor(s) behalf but at the Publishers' expense, any action including legal action, that the Publishers may consider necessary to protect their rights under this agreement arising out of their copyright in the work. However if the Author(s)/Editor(s) chooses to retain the copyright to themselves, all costs mentioned herein will have to be borne by the Author(s)/Editor(s).
- 19. Termination: If at any time an edition or printing of the work becomes out of print and continues to be out of print for a period of twelve months and the Publishers neglect to issue a reprint or a new edition of the work within twelve months of receipt of a notice in writing from the Author(s) / Editor(s) subsequent to the work being out of print for twelve months, all rights in the work will revert to the Author(s) / Editor(s) and this agreement shall stand cancelled. This cancellation will not, however, prejudice rights in the work acquired by third parties during the period of its operation. In cases of translations, abridgements and adaptations of the work published by the Publishers themselves, the publishers will continue to enjoy exclusive rights for these till all copies on hand on the date of termination of the agreement have been sold out.
- **20. Jurisdiction:** All differences or disputes arising out of or in connection with interpretation or enforcement of this agreement shall be subject thereto the Courts in Delhi only.
