Regular Transducer Expressions for Regular Transformations

Abstract.

Functional MSO transductions, deterministic two-way transducers, as well as streaming string transducers are all equivalent models for regular functions. In this paper, we show that every regular function, either on finite words or on infinite words, captured by a deterministic two-way transducer, can be described with a regular transducer expression (RTE). For infinite words, the transducer uses Muller acceptance and ω -regular look-ahead. RTEs are constructed from constant functions using the combinators if-then-else (deterministic choice), Hadamard product, and unambiguous versions of the Cauchy product, the 2-chained Kleene-iteration and the 2chained omega-iteration. Our proof works for transformations of both finite and infinite words, extending the result on finite words of Alur et al. in LICS'14. In order to construct an RTE associated with a deterministic two-way Muller transducer with look-ahead, we introduce the notion of transition monoid for such two-way transducers where the look-ahead is captured by some backward deterministic Büchi automaton. Then, we use an unambiguous version of Imre Simon's famous forest factorization theorem in order to derive a "good" (ω -)regular expression for the domain of the two-way transducer. "Good" expressions are unambiguous and Kleene-plus as well as ω -iterations are only used on subexpressions corresponding to idempotent elements of the transition monoid. The combinator expressions are finally constructed by structural induction on the "good" (ω -)regular expression describing the domain of the transducer.

1 Introduction

One of the most fundamental results in theoretical computer science is that the class of regular languages corresponds to the class of languages recognised by finite state automata, to the class of languages definable in MSO, and to the class of languages whose syntactic monoid is finite. Regular languages are also those that can be expressed using a regular expression; this equivalence is given by the Kleene's theorem. This beautiful correspondence between machines, logics and algebra in the case of regular languages paved the way to generalizations of this fundamental theory to regular transformations [14], where, it was shown that regular transformations are those which are captured by two-way transducers and by MSO transductions a la Courcelle. Much later, streaming string transducers (SSTs) were introduced [1] as a model which makes a single pass through the input string and use a finite set of variables that range over strings from the output alphabet. [1] established the equivalence between SSTs and MSO transductions, thereby showing that regular transformations are those which are captured by either SSTs, two-way transducers or MSO transductions. This theory was further extended to work for infinite string transformations [4]; the restriction from MSO transductions to first-order definable transductions, and their equivalence with aperiodic SSTs and aperiodic two-way transducers has also been established over finite and infinite strings [15], [12]. Other generalizations such as [2], extend this theory to trees. Most recently, this equivalence between SSTs and logical transductions are also shown to hold good even when one works with the origin semantics [6].

Moving on, an interesting generalization pertains to the characterization of the output computed by two-way transducers or SSTs (over finite and infinite words) using regular-like expressions. For the strictly lesser expressive case of sequential one-way transducers, this regex characterization of the output is obtained as a special case of Schützenberger's famous equivalence [13] between weighted automata and regular weighted expressions. The question is much harder when one looks at two-way transducers, due to the fact that the output is generated in a one-way fashion, while the input is read in a two-way manner. The most recent result known in this direction is [5], which provides a set of combinators, analogous to the operators used in forming regular expressions. These combinators are used to form combinator expressions which compute the output of an additive cost register automaton (ACRA) over finite words. ACRAs are generalizations of SSTs and compute a partial function from finite words over a finite alphabet to values from a monoid $(\mathbb{D}, +, 0)$ (SSTs are ACRAs where $(\mathbb{D}, +, 0)$ is the free monoid $(\Gamma^*, ., \epsilon)$ for some finite output alphabet Γ). The combinators introduced in [5] form the basis for a declarative language DReX [3] over finite words, which can express all regular string-to-string transformations, and can also be efficiently evaluated.




Figure 1 On the left, a 2DFT \mathcal{A} with $[\![\mathcal{A}]\!](ba^{m_1}ba^{m_2}b\dots a^{m_k}b) = a^{m_2}b^{m_1}a^{m_3}b^{m_2}\dots a^{m_k}b^{m_{k-1}}$. On the right, an ω -2DMTla \mathcal{A}' with $[\![\mathcal{A}']\!](u_1\#u_2\#\ldots\#u_n\#v) = u_1^Ru_1\#u_2^Ru_2\#\ldots\#u_n^Ru_n\#v$ where $u_1, \ldots, u_n \in (a+b)^*, v \in (a+b)^\omega$ and u^R denotes the reverse of u. The Muller acceptance set is $\{\{q_5\}\}\$. The look-ahead expressions $\Sigma^* \# \Sigma^\omega$ and $(\Sigma \setminus \{\#\})^\omega$ are used to check if there is a # in the remaining suffix of the input word.

Our Contributions. We generalize the result of [5]. Over finite words, we work with twoway deterministic transducers (denoted 2DFT, see Figure 1 left) while over infinite words, the model considered is a deterministic two-way transducer with regular look-ahead, equipped with the Muller acceptance condition. For example, Figure 1 right gives an ω -2DMTla (la stands for look-ahead and M in the 2DMT for Muller acceptance).

In both cases of finite words and infinite words, we come up with a set of combinators using which, we form regular transducer expressions (RTE) characterizing the output of the two-way transducer (2DFT/ ω -2DMTla).

The Combinators. We describe our basic combinators that form the building blocks of RTEs. The semantics of an RTE is a partial function $f: \Sigma^{\infty} \to \Gamma^{\infty}$ whose domain is denoted dom(f).

■ We first look at the case of finite words and describe the basic combinators. The constant function is one which maps all strings in Σ^* to some fixed value d. Given a string $w \in \Sigma^*$, the if-then-else combinator K?f:g checks if w is in the regular language K or not, and appropriately produces f(w) or g(w). The unambiguous Cauchy product $f \odot g$ when applied on $w \in \Sigma^*$ produces $f(u) \cdot g(v)$ if $w = u \cdot v$ is an unambiguous decomposition of w with $u \in \mathsf{dom}(f)$ and $v \in \mathsf{dom}(g)$. The unambiguous Kleene-plus f^{\boxplus} when applied to $w \in \Sigma^*$ produces $f(u_1)\cdots f(u_n)$ if $w=u_1\cdots u_n$ is an unambiguous factorization of w, with each $u_i \in \mathsf{dom}(f)$. The Hadamard product $f \odot g$ when applied to w produces $f(w) \cdot g(w)$. Finally, the unambiguous 2-chained Kleene-plus $[K,f]^{2\boxplus}$ when applied to a string w produces as

- In the case of infinite words, the Cauchy product $f \subseteq g$ works on $w \in \Sigma^{\omega}$ if w can be written unambiguously as $u \cdot v$ with $u \in \mathsf{dom}(f) \cap \Sigma^*$ and $v \in \mathsf{dom}(g) \cap \Sigma^{\omega}$. Another difference is in the use of the Hadamard product: for $w \in \Sigma^{\omega}$, $f \odot g$ produces $f(w) \cdot g(w)$ if f(w) is a finite string. Note that these are sound with respect to the concatenation semantics for infinite words. Indeed, we also have ω -iteration and two-chained ω -iteration: $f^{\omega}(w) = f(u_1)f(u_2) \cdots$ if $w \in \Sigma^{\omega}$ can be unambiguously decomposed as $w = u_1u_2 \cdots$ with $u_i \in \mathsf{dom}(f) \cap \Sigma^*$ for all $i \geq 1$. Moreover, $[K, f]^{2\omega}(w) = f(u_1u_2)f(u_2u_3) \cdots$ if $w \in \Sigma^{\omega}$ can be unambiguously decomposed as $w = u_1u_2 \cdots$ with $u_i \in K$ for all $i \geq 1$, where $K \subseteq \Sigma^*$ is regular.
- An RTE is formed using all the above basic combinators.
- As an example, consider the RTE $C = C_4^{\boxplus} \boxdot C_2^{\omega}$ with $C_4 = ((a+b)^*\#)?(C_3^{\boxdot} \boxdot C_1^{\boxplus}):\bot$, $C_2 = a?a:(b?b:\bot)$. Here, $C_1 = a?a:(b?b:(\#?\#:\bot))$, and $C_3 = a?a:(b?b:(\#?\epsilon:\bot))$. Then $dom(C_1) = dom(C_3) = (a+b+\#)$, $dom(C_2) = (a+b)$, $dom(C_4) = (a+b)^*\#$ and, for $u \in (a+b)^*$, $\llbracket C_4 \rrbracket (u\#) = u^R u\#$ where u^R denotes the reverse of u. This gives $dom(C) = [(a+b)^*\#]^+(a+b)^{\omega}$ with $\llbracket C \rrbracket (u_1\#u_2\#\cdots u_n\#v) = u_1^R u_1\#u_2^R u_2\#\cdots \#u_n^R u_n\#v$ when $u_i \in (a+b)^*$ and $v \in (a+b)^{\omega}$. The RTE $C' = (a+b)^{\omega}?C_2^{\omega}:C$ corresponds to the ω-2DMTla A' in Figure 1; that is, $\llbracket C' \rrbracket = \llbracket A' \rrbracket$.
- The combinators proposed in [5] also require unambiguity in concatenation and iteration. The base function L/d in [5] maps all strings in language L to the constant d, and is undefined for strings not in L. This can be written using our if-then-else $L?d:\bot$. The conditional choice combinator $f \triangleright g$ of [5] maps an input σ to $f(\sigma)$ if it is in dom(f), and otherwise it maps it to $g(\sigma)$. This can be written in our if-then-else as dom(f)?f:g. The split-sum combinator $f \oplus g$ of [5] is our Cauchy product $f \boxdot g$. The iterated sum Σf of [5] is our Kleene-plus f^{\boxplus} . The left-split-sum and left-iterated sum of [5] are counterparts of our reverse Cauchy product $f \boxdot g$ and reverse Kleene-plus f^{\boxplus} . The sum f+g of two functions in [5] is our Hadamard product $f \odot g$. Finally, the chained sum $\Sigma(f,L)$ of [5] is our two-chained Kleene-plus $[L,f]^{2\boxplus}$. In our case, the terminology is all inspired from weighted automata literature, and the unambiguity comes from the use of the unambiguous factorization of the domain into good expressions, and we also extend our RTEs to infinite words.

Our main result is that two-way deterministic transducers and regular transducer expressions are effectively equivalent, both for finite and infinite words. See Appendix A.2 for a practical example using transducers.

Theorem 1. (1) Given an RTE (resp. ω -RTE) we can effectively construct an equivalent 2DFT (resp. an ω -2DMTIa). Conversely, (2) given a 2DFT (resp. an ω -2DMTIa) we can effectively construct an equivalent RTE (resp. ω -RTE).

The proof of (1) is by structural induction on the RTE. The construction of an RTE starting from a two-way deterministic transducer \mathcal{A} is quite involved. It is based on the transition monoid $TrM(\mathcal{A})$ of the transducer. This is a classical notion for two-way transducers over finite words, but not for two-way transducers with look-ahead on infinite words (to the best of our knowledge). So we introduce the notion of transition monoid for ω -2DMTla. We handle the look-ahead with a backward deterministic Büchi automaton (BDBA), also called complete unambiguous or strongly unambiguous Büchi automata [7, 18]. The translation of \mathcal{A} to an RTE is crucially guided by a "good" rational expression induced by the transition monoid of \mathcal{A} . These "good" expressions are

obtained thanks to an unambiguous version [16] of the celebrated forest factorization theorem due to Imre Simon [17]. The unambiguous forest factorization theorem implies that, given a two-way transducer \mathcal{A} , any input word w in the domain of \mathcal{A} can be factorized unambiguously following a "good" rational expression induced by the transition monoid of \mathcal{A} . This unambiguous factorization then guides the construction of the RTE corresponding to \mathcal{A} . This algebraic backdrop facilitates a uniform treatment in the case of infinite words and finite words. As a remark, it is not apriori clear how the result of [5] extends to infinite words using the techniques therein.

Goodness of Rational Expressions. The goodness of a rational expression over alphabet Σ is defined using a morphism φ from Σ^* to a monoid $(S,.,1_S)$. A rational expression F is good iff (i) it is unambiguous and (ii) for each subexpression E of F, the image of all strings in L(E) maps to a single monoid element s_E , and (iii) for each subexpression E^+ of F, s_E is an idempotent. Note that unambiguity ensures the functionality of the output computed. Good rational expressions might be useful in settings beyond two-way transducers.

Computing the RTE. As an example, we now show how one computes an RTE equivalent to the 2DFT A on the left of Figure 1.

- 1. We work with the morphism $\operatorname{Tr} : \Sigma^* \to \operatorname{TrM}$ which maps words $w \in \Sigma^*$ to the transition monoid TrM of \mathcal{A} . An element $X \in \operatorname{TrM}$ is a set consisting of triples (p,d,q), where d is a direction $\{\supset, \subset, \to, \leftarrow\}$. Given a word $w \in \Sigma^*$, a triple $(p,\supset,q) \in \operatorname{Tr}(w)$ iff when starting in state p on the left most symbol of w, the run of \mathcal{A} leaves w on the left in state q. The other directions \subset (start at the rightmost symbol of w in state p and leave w on the right in state q), \leftarrow and \rightarrow are similar. In general, we have $w \in \operatorname{dom}(\mathcal{A})$ iff on input $\vdash w \dashv$, starting on \vdash in the initial state of \mathcal{A} , the run exits on the right of \dashv in some final state of \mathcal{A} . With the automaton \mathcal{A} on the left of Figure 1 we have $w \in \operatorname{dom}(\mathcal{A})$ iff $(q_0, \to, q_2) \in \operatorname{Tr}(w)$.
- 2. For each $X \in \mathsf{TrM}$ such that $(q_0, \to, q_2) \in X$, we find an RTE C_X whose domain is $\mathsf{Tr}^{-1}(X)$ and such that $[\![\mathcal{A}]\!](w) = [\![C_X]\!](w)$ for all $w \in \mathsf{Tr}^{-1}(X)$. The RTE corresponding to $[\![\mathcal{A}]\!]$ is the disjoint union of all these RTEs and is written using the if-then-else construct iterating over for all such elements X. For instance, if the monoid elements containing (q_0, \to, q_2) are X_1, X_2, X_3 then we set $C = \mathsf{Tr}^{-1}(X_1) ? C_{X_1} : (\mathsf{Tr}^{-1}(X_2) ? C_{X_2} : (\mathsf{Tr}^{-1}(X_3) ? C_{X_3} : \bot))$ where \bot stands for a nowhere defined function, i.e., $\mathsf{dom}(\bot) = \emptyset$.




Figure 2 Run of \mathcal{A} on an input word in $(ba^+)^+b$.

- 3. Consider the language $L = (ba^+)^+b \subseteq \mathsf{dom}(\mathcal{A})$. Notice that the regular expression $(ba^+)^+b$ is not "good". For instance, condition (ii) is violated since $\mathsf{Tr}(bab) \neq \mathsf{Tr}(babab)$. Indeed, we can seen in Figure 2 that if we start on the right of bab in state q_3 then we exist on the left in state q_5 : $(q_3, \leftarrow, q_5) \in \mathsf{Tr}(bab)$. On the other hand, if we start on the right of babab in state q_3 then we exist on the right in state q_2 : $(q_3, \subset, q_2) \in \mathsf{Tr}(babab)$. Also, $(q_5, \rightarrow, q_1) \in \mathsf{Tr}(bab)$ while $(q_5, \rightarrow, q_2) \in \mathsf{Tr}(babab)$. It can be seen that $\mathsf{Tr}(a)^1$ is an idempotent, hence $\mathsf{Tr}(a^+) = \mathsf{Tr}(a)$. We deduce also $\mathsf{Tr}(ba^+b) = \mathsf{Tr}(bab)^2$. Finally, we have $\mathsf{Tr}((ba^+)^nb) = \mathsf{Tr}(babab)^3$ for all $n \geq 2$. Therefore, to obtain the RTE corresponding to L, we compute RTEs corresponding to ba^+b and $(ba^+)^+ba^+b$ satisfying conditions (i) and (ii) of "good" rational expressions.
- 4. While ba^+b is good since $\operatorname{Tr}(a)$ is an idempotent, $(ba^+)^+ba^+b$ is not good, the reason being that $\operatorname{Tr}(ba^+)$ is not an idempotent. We can check that $\operatorname{Tr}(ba^+ba^+)^4$ is still not idempotent, while $\operatorname{Tr}((ba^+)^i) = \operatorname{Tr}((ba^+)^3)$ for all $i \geq 3$, (see Figure 2: we only need to argue for $(q_0, \rightarrow q_3), (q_5, \rightarrow, q_3)$ and (q_6, \rightarrow, q_3) in $\operatorname{Tr}((ba)^i), i \geq 3$, all other entries trivially carry over). In

particular, $\text{Tr}((ba^+)^3)$ is an idempotent⁵. Thus, to compute the RTE for $L=(ba^+)^+b$, we consider the RTEs corresponding to the "good" regular expressions $E_1=ba^+b$, $E_2=ba^+ba^+b$, $E_3=[(ba^+)^3]^+b$, $E_4=[(ba^+)^3]^+ba^+b$ and $E_5=[(ba^+)^3]^+ba^+ba^+b$.

5. We define by induction, for each "good" expression E and "step" x=(p,d,q) in the monoid element $X=\operatorname{Tr}(E)$ associated with E, an RTE $C_E(x)$ whose domain is E and, given a word $w\in E$, it computes $\llbracket C_E(x) \rrbracket(w)$ the output of $\mathcal A$ when running step x on w. For instance, if E=a and $x=(q_5,\leftarrow,q_5)$ the output is b so we set $C_a(q_5,\leftarrow,q_5)=(a\,?\,b:\bot)$. The ifthen-else ensures that the domain is a. Similarly, we get the RTE associated with all atomic expressions and steps. For instance, $C_b(q_1,\to,q_2)=(b\,?\,\varepsilon:\bot)=C_b(q_3,\searrow,q_4)$. For $u,v\in\Sigma^*$, we introduce the macro $u/v=u\,?\,v:\bot$. We have $\operatorname{dom}(u/v)=\{u\}$ and $\llbracket u/v \rrbracket(u)=v$. We turn to the good expression a^+ . If we start on the right of a word $w\in a^+$ from state q_5 then we read the word from right to left using always the step (q_5,\leftarrow,q_5) . Therefore, we have $C_{a^+}(q_5,\leftarrow,q_5)=(C_a(q_5,\leftarrow,q_5))^{\stackrel{\leftarrow}{\boxplus}}=(a/b)^{\stackrel{\leftarrow}{\boxplus}}$. Similarly, $C_{a^+}(q_4,\leftarrow,q_4)=(a/a)^{\stackrel{\leftarrow}{\boxplus}}$, $C_{a^+}(q_1,\to,q_1)=(a/\varepsilon)^{\stackrel{\leftarrow}{\boxplus}}=C_{a^+}(q_6,\to,q_6)$. Now if we start on the left of a word $w\in a^+$ from state q_2 then we first take the step (q_2,\to,q_3) and then we iterate the step (q_3,\to,q_3) . Therefore, we have $C_{a^+}(q_2,\to,q_3)=a\,?\,C_a(q_2,\to,q_3):(C_a(q_2,\to,q_3):(C_a(q_3,\to,q_3))^{\stackrel{\leftarrow}{\boxplus}})=a\,?\,(a/\varepsilon):((a/\varepsilon):(a/\varepsilon):(a/\varepsilon)^{\stackrel{\leftarrow}{\boxplus}})$, which is equivalent to the RTE $(a/\varepsilon)^{\stackrel{\leftarrow}{\boxplus}}$.

More interesting is the step $y = (q_4, \zeta, q_1)$ since on a word $w \in E$, the run which starts on the right in state q_4 goes all the way to the left until it reads the first b in state q_5 and then moves to the right until it exists in state q_1 (see Figure 2). Therefore, we have

$$\approx (b/\varepsilon) \stackrel{\leftarrow}{\Box} (a/b) \stackrel{\rightleftharpoons}{\Box} \stackrel{\leftarrow}{\Box} (b/\varepsilon) \stackrel{\leftarrow}{\Box} (a/a) \stackrel{\rightleftharpoons}{\Box} .$$

The leftmost (b/ε) in the first line is used to make sure that the input word belongs to $E = ba^+ba^+$. Composing these steps on the right with b, we obtain the RTE $C_2 = C_{E_2}(q_0, \to, q_2)$

which describes the behaviour of \mathcal{A} on the subset $E_2 = ba^+ba^+b \subseteq \mathsf{dom}(\mathcal{A})$:

$$C_{2} = (C_{E}(x) \boxdot C_{b}(q_{3}, \triangleright, q_{4})) \odot (C_{E}(y) \boxdot C_{b}(q_{1}, \rightarrow, q_{2}))$$

$$= (C_{E}(x) \boxdot (b/\varepsilon)) \odot (C_{E}(y) \boxdot (b/\varepsilon))$$

$$\approx ((b/\varepsilon) \overleftarrow{\boxdot} (a/b) \overleftarrow{\boxminus} \overleftarrow{\boxdot} (b/\varepsilon) \overleftarrow{\boxdot} (a/a) \overleftarrow{\boxminus}) \boxdot (b/\varepsilon).$$

Therefore, $[C_2](ba^{m_1}ba^{m_2}b) = a^{m_2}b^{m_1} = [A](ba^{m_1}ba^{m_2}b).$ In Appendix A.1, we show the computation of the RTE $C_{E_3}(q_0, \to, q_2)$ for $E_3 = [(ba^+)^3]^+b \subseteq$ dom(A).

2 **Finite Words**

We start with the definition of two-way automata and transducers for the case of finite words.

2.1 Two-way automata and transducers

Let Σ be a finite input alphabet and let \vdash , \dashv be two special symbols not in Σ . We assume that every input string $w \in \Sigma^*$ is presented as $\vdash w \dashv$, where \vdash , \dashv serve as left and right delimiters that appear nowhere else in w. We write $\Sigma_{\vdash,\dashv} = \Sigma \cup \{\vdash,\dashv\}$. A two-way automaton $\mathcal{A} = (Q, \Sigma, \delta, I, F)$ has a finite set of states Q, subsets $I, F \subseteq Q$ of initial and final states and a transition relation $\delta \subseteq Q \times \Sigma_{\vdash \dashv} \times Q \times \{-1,1\}$. The -1 represents the reading head moving to the left, while a 1 represents the reading head moving to the right. The reading head cannot move left when it is on \vdash . A configuration of \mathcal{A} is represented by w_1qw_2 where $q \in Q$ and $w_1w_2 \in \vdash \Sigma^* \dashv$. If $w_2 = \varepsilon$ the computation has come to an end. Otherwise, the reading head of A is scanning the first symbol of $w_2 \neq \varepsilon$ in state q. If $w_2 = aw_2'$ and if $(q, a, q', -1) \in \delta$ (hence $a \neq \vdash$), then there is a transition from the configuration $w_1'bqaw_2'$ to $w_1'q'baw_2'$. Likewise, if $(q, a, q', 1) \in \delta$, we obtain a transition from w_1qaw_2' to $w_1aq'w_2'$. A run of \mathcal{A} is a sequence of transitions; it is accepting if it starts in a configuration $p \vdash w \dashv$ with $p \in I$ and ends in a configuration $\vdash w \dashv q$ with $q \in F$. The language $\mathcal{L}(\mathcal{A})$ or domain $\mathsf{dom}(\mathcal{A})$ of \mathcal{A} is the set of all words $w \in \Sigma^*$ which have an accepting run in \mathcal{A} .

To extend the definition of a two-way automaton \mathcal{A} into a two-way transducer, $(Q, \Sigma, \delta, I, F)$ is extended to $(Q, \Sigma, \Gamma, \delta, I, F)$ by adding a finite output alphabet Γ and the definition of the transition relation as a *finite* subset $\delta \subseteq Q \times \Sigma_{\vdash \dashv} \times Q \times \Gamma^* \times \{-1,1\}$. The output produced on each transition is appended to the right of the output produced so far. \mathcal{A} defines a relation $[\![\mathcal{A}]\!] = \{(u, w) \mid u \in \mathcal{L}(\mathcal{A}) \text{ and } w \text{ is the output produced on an accepting run of } u\}.$

The transducer \mathcal{A} is said to be functional if for each input $u \in \mathsf{dom}(\mathcal{A})$, at most one output w can be produced. In this case, for each $u \in \mathsf{dom}(\mathcal{A})$ in the domain, there is exactly one $w \in \Gamma^*$ such that $(u, w) \in [\![\mathcal{A}]\!]$. We also denote this by $[\![\mathcal{A}]\!](u) = w$. We consider a special symbol $\bot \notin \Gamma$ that will stand for undefined. We let $[A](u) = \bot$ when $u \notin dom(A)$. Thus, the semantics of a functional transducer \mathcal{A} is a map $[\![\mathcal{A}]\!]: \Sigma^* \to \mathbb{D} = \Gamma^* \cup \{\bot\}$ such that $u \in \mathsf{dom}(\mathcal{A})$ iff $[\![\mathcal{A}]\!](u) \neq \bot$.

We use non-deterministic unambiguous two-way transducers (2NUFT) in some proofs. A two-way transducer is unambiguous if each string $u \in \Sigma^*$ has at most one accepting run. Clearly, 2NUFTs are functional. A deterministic two-way transducer (2DFT) is one having a single initial state and where, from each state, on each symbol $a \in \Sigma_{\vdash \dashv}$, at most one transition is enabled. In that case, the transition relation is a partial function $\delta: Q \times \Sigma_{\vdash \dashv} \to Q \times \Gamma^* \times \{-1,1\}$. 2DFTs are by definition unambiguous. It is known [8] that 2DFTs are equivalent to 2NUFTs.

A 1DFT (1NUFT) represents a deterministic (non-deterministic unambiguous) transducer where the reading head only moves to the right.

Example 2. On the left of Figure 1, a two-way transducer \mathcal{A} is given with $dom(\mathcal{A}) = (ba^*)^+b$, $[A](ba^{m_1}b) = \varepsilon$ and $[A](ba^{m_1}ba^{m_2}b\cdots a^{m_k}b) = a^{m_2}b^{m_1}a^{m_3}b^{m_2}\cdots a^{m_k}b^{m_{k-1}}$ for $k \ge 2$.

2.2 Regular Transducer Expressions

Let Σ and Γ be finite input and output alphabets. Recall that $\bot \notin \Gamma$ is a special symbol that stands for *undefined*. We define the output monoid as $\mathbb{D} = \Gamma^* \cup \{\bot\}$ with the usual concatenation on words, \bot acting as a zero: $d \cdot \bot = \bot \cdot d = \bot$ for all $d \in \mathbb{D}$. The unit is the empty word $\mathbf{1}_{\mathbb{D}} = \varepsilon$.

We define Regular Transducer Expressions (RTE) from Σ^* to \mathbb{D} using some basic combinators. The syntax of RTE is defined with the following grammar:

$$C ::= d \mid K \mathbin{?} C : C \mid C \odot C \mid C \boxdot C \mid C \boxdot C \mid C^{\boxminus} \mid C^{\boxminus} \mid [K,C]^{2\boxminus} \mid [K,C]^{2} \mid [K$$

where $d \in \mathbb{D}$ ranges over output values, and $K \subseteq \Sigma^*$ ranges over regular languages of *finite words*. The semantics of an RTE C is a function $[\![C]\!]: \Sigma^* \to \mathbb{D}$ defined inductively following the syntax of the expression, starting from constant functions. Since \bot stands for *undefined*, we define the domain of a function $f: \Sigma^* \to \mathbb{D}$ by $\operatorname{dom}(f) = f^{-1}(\mathbb{D} \setminus \{\bot\}) = \Sigma^* \setminus f^{-1}(\bot)$.

Constants. For $d \in \mathbb{D}$, we let $\llbracket d \rrbracket$ be the constant map defined by $\llbracket d \rrbracket(w) = d$ for all $w \in \Sigma^*$. We have $\mathsf{dom}(\llbracket d \rrbracket) = \Sigma^*$ if $d \neq \bot$ and $\mathsf{dom}(\llbracket \bot \rrbracket) = \emptyset$.

Each regular combinator defined above allows to combine functions from Σ^* to \mathbb{D} . For functions $f,g\colon \Sigma^*\to \mathbb{D},\ w\in \Sigma^*$ and a regular language $K\subseteq \Sigma^*$, we define the following combinators.

If then else. (K? f:g)(w) is defined as f(w) for $w \in K$, and g(w) for $w \notin K$.

We have $dom(K? f: g) = (dom(f) \cap K) \cup (dom(g) \setminus K)$.

Hadamard product. $(f \odot g)(w) = f(w) \cdot g(w)$ (recall that $(\mathbb{D}, \cdot, \mathbf{1}_{\mathbb{D}})$ is a monoid).

We have $dom(f \odot g) = dom(f) \cap dom(g)$.

Unambiguous Cauchy product and its reverse. If w admits a unique factorization $w = u \cdot v$ with $u \in \mathsf{dom}(f)$ and $v \in \mathsf{dom}(g)$ then we set $(f \boxdot g)(w) = f(u) \cdot g(v)$ and $(f \boxdot g)(w) = g(v) \cdot f(u)$. Otherwise, we set $(f \boxdot g)(w) = \bot = (f \boxdot g)(w)$.

We have $dom(f \boxdot g) = dom(f \boxdot g) \subseteq dom(f) \cdot dom(g)$ and the inclusion is strict if the concatenation of dom(f) and dom(g) is ambiguous.

Unambiguous Kleene-plus and its reverse. If w admits a unique factorization $w = u_1 \cdot u_2 \cdots u_n$ with $n \geq 1$ and $u_i \in \mathsf{dom}(f)$ for all $1 \leq i \leq n$ then we set $f^{\boxplus}(w) = f(u_1) \cdot f(u_2) \cdots f(u_n)$ and $f^{\boxminus}(w) = f(u_n) \cdots f(u_2) \cdot f(u_1)$. Otherwise, we set $f^{\boxminus}(w) = \bot = f^{\boxminus}(w)$.

We have $\mathsf{dom}(f^{\boxplus}) = \mathsf{dom}(f^{\boxdot}) \subseteq \mathsf{dom}(f)^+$ and the inclusion is strict if the Kleene iteration $\mathsf{dom}(f)^+$ of $\mathsf{dom}(f)$ is ambiguous. Notice that $\mathsf{dom}(f^{\boxplus}) = \emptyset$ when $\varepsilon \in \mathsf{dom}(f)$.

Unambiguous 2-chained Kleene-plus and its reverse. If w admits a unique factorization $w = u_1 \cdot u_2 \cdots u_n$ with $n \geq 1$ and $u_i \in K$ for all $1 \leq i \leq n$ then we set $[K, f]^{2\boxplus}(w) = f(u_1u_2) \cdot f(u_2u_3) \cdots f(u_{n-1}u_n)$ and $[K, f]^{2\boxplus}(w) = f(u_{n-1}u_n) \cdots f(u_2u_3) \cdot f(u_1u_2)$ (if n = 1, the empty product gives the unit of \mathbb{D} : $[K, f]^{2\boxplus}(w) = \mathbf{1}_{\mathbb{D}} = [K, f]^{2\boxplus}(w)$). Otherwise, we set $[K, f]^{2\boxplus}(w) = \bot = [K, f]^{2\boxplus}(w)$.

Again, we have $\operatorname{dom}([K,f]^{2\boxplus}) = \operatorname{dom}([K,f]^{2\boxplus}) \subseteq K^+$ and the inclusion is strict if the Kleene iteration K^+ of K is ambiguous. Notice that, even if $w \in K^+$ admits a unique factorization $w = u_1 \cdot u_2 \cdots u_n$ with $u_i \in K$ for all $1 \leq i \leq n$, w is not necessarily in the domain of $[K,f]^{2\boxplus}$ or $[K,f]^{2\boxplus}$. For w to be in this domain, it is further required that $u_1u_2, u_2u_3, \ldots, u_{n-1}u_n \in \operatorname{dom}(f)$. Notice that we have $\operatorname{dom}([K,f]^{2\boxplus}) = \operatorname{dom}([K,f]^{2\boxplus}) = K^+$ when K^+ is unambiguous and $K^2 \subseteq \operatorname{dom}(f)$.

Lemma 3. The domain of an RTE C is a regular language $dom(C) \subseteq \Sigma^*$.

Remark. Notice that the reverse Cauchy product is redundant, it can be expressed with the Hadamard product and the Cauchy product:

$$f \stackrel{\longleftarrow}{\boxdot} g = ((\mathsf{dom}(f) ? \varepsilon : \bot) \boxdot g) \odot (f \boxdot (\mathsf{dom}(g) ? \varepsilon : \bot)).$$

The unambiguous Kleene-plus is also redundant, it can be expressed with the unambiguous 2chained Kleene-plus:

$$f^{\boxplus} = [\mathsf{dom}(f), f \boxdot (\mathsf{dom}(f)\,?\,\varepsilon:\bot)]^{2\boxplus} \odot ((\mathsf{dom}(f)^*\,?\,\varepsilon:\bot)\boxdot f)\,.$$

Example 4. Consider the RTEs $C_1 = ([(a+b)^+ \#]? \varepsilon : \bot) \boxdot ((a+b)^+? \mathsf{copy} : \bot), C_2 = \# \text{ and } C_3 = ((a+b)^+ \#)? \varepsilon : \bot)$ $((a+b)^+?\operatorname{copy}:\bot) \boxdot ([\#(a+b)^+]?\varepsilon:\bot), \text{ where } \operatorname{copy} = (a?a:(b?b:\bot))^{\boxplus}. \text{ Then, } \operatorname{dom}(\llbracket C_2 \rrbracket) = (a?a:(b?b:\bot))^{\boxplus}.$ Σ^* , dom([copy]) = $(a+b)^+$ and dom([C_1]) = dom([C_3]) = $(a+b)^+$ # $(a+b)^+$. Moreover, $[C_1 \odot C_2 \odot C_3](u \# v) = v \# u \text{ for all } u, v \in (a+b)^+.$

Example 5. Consider the RTEs $C_a = (b?\varepsilon:\bot) \boxdot (a?a:\bot)^{\boxplus}$ and $C_b = (b?\varepsilon:\bot) \boxdot (a?b:\bot)^{\boxplus}$. We have $\operatorname{\mathsf{dom}}(\llbracket C_a \rrbracket) = ba^+ = \operatorname{\mathsf{dom}}(\llbracket C_b \rrbracket)$ and $\llbracket C_a \rrbracket(ba^n) = a^n$ and $\llbracket C_b \rrbracket(ba^n) = b^n$. We deduce that $\operatorname{dom}(\llbracket C_b \overleftarrow{\boxdot} C_a \rrbracket) = ba^+ba^+$ and $\llbracket C_b \overleftarrow{\boxdot} C_a \rrbracket(ba^nba^m) = a^mb^n$.

Consider the expression $C = [ba^+, C_b \stackrel{\leftarrow}{\boxdot} C_a]^{2\boxplus} \stackrel{\smile}{\boxdot} (b?\varepsilon:\bot)$. Then, $\mathsf{dom}(\llbracket C \rrbracket) = (ba^+)^+b$, $[\![C]\!](ba^mb) = \varepsilon$ and $[\![C]\!](ba^{m_1}ba^{m_2}b\cdots a^{m_k}b) = a^{m_2}b^{m_1}a^{m_3}b^{m_2}\cdots a^{m_k}b^{m_{k-1}}$ for $k \ge 2$.

Theorem 6. 2DFTs and RTEs define the same class of functions. More precisely,

- 1. given an RTE C, we can construct a 2DFT A such that [A] = [C],
- **2.** given a 2DFT \mathcal{A} , we can construct an RTE C such that [A] = [C].

The proof of (1) is given in the next section, while the proof of (2) will be given in Section 2.6 after some preliminaries in Section 2.5 on transition monoids for 2DFTs and the unambiguous forest factorization theorem.

2.3 RTE to 2DFT

In this section, we prove Theorem 6(1), i.e., we show that given an RTE C, we can construct a 2DFT \mathcal{A} such that $[\![\mathcal{A}]\!] = [\![\mathcal{C}]\!]$. We do this by structural induction on RTEs, starting with constant functions, and then later showing that 2DFTs are closed under all the combinators used in RTEs.

Constant functions: We start with the constant function $d \in \mathbb{D}$ for which it is easy to construct a 2DFT \mathcal{A} such that $[\![d]\!] = [\![\mathcal{A}]\!]$. For $d = \bot$, we take \mathcal{A} such that $\mathsf{dom}(\mathcal{A}) = \emptyset$ (for instance we use a single state and an empty transition function). Assume now that $d \in \Gamma^*$. The 2DFT scans the word up to the right end marker, outputs d and stops. Formally, we let $\mathcal{A} = (\{q\}, \Sigma, \Gamma, \delta, q, \{q\})$ s.t. $\delta(q,a)=(q,\varepsilon,+1)$ for all $a\in\Sigma\cup\{\vdash\}$ and $\delta(q,\dashv)=(q,d,+1)$. Clearly, $[\![\mathcal{A}]\!](w)=d$ for all $w \in \Sigma^*$.

The inductive steps follow directly from:

Lemma 7. Let $K \subseteq \Sigma^*$ be regular, and let f and g be RTEs with $[\![f]\!] = [\![M_f]\!]$ and $[\![g]\!] = [\![M_g]\!]$ for 2DFTs M_f and M_q respectively. Then, one can construct

- 1. a 2DFT \mathcal{A} such that $[K? f:g] = [\mathcal{A}]$.
- **2.** a 2DFT \mathcal{A} such that $[\![\mathcal{A}]\!] = [\![f \odot g]\!]$.
- 3. $2DFTs \ \mathcal{A}, \ \mathcal{B} \ such \ that \ [\![\mathcal{A}]\!] = [\![f \boxdot g]\!] \ and \ [\![\mathcal{B}]\!] = [\![f \overleftarrow{\boxdot} g]\!].$
- **4.** $2DFTs \ \mathcal{A}, \ \mathcal{B} \ such \ that \ \llbracket \mathcal{A} \rrbracket = \llbracket f^{\boxplus} \rrbracket \ and \ \llbracket \mathcal{B} \rrbracket = \llbracket f^{\boxminus} \rrbracket.$
- **5.** $2DFTs \ \mathcal{A}, \ \mathcal{B} \ such \ that \ \llbracket \mathcal{A} \rrbracket = \llbracket [K, f]^{2 \boxplus} \rrbracket \ and \ \llbracket \mathcal{B} \rrbracket = \llbracket [K, f]^{2 \boxplus} \rrbracket.$

Proof. (1) If then else. Let \mathcal{B} be a complete DFA that accepts the regular language K. The idea of the proof is to construct a 2DFT \mathcal{A} which first runs \mathcal{B} on the input w until the end marker \dashv is reached in some state q of \mathcal{B} . Then, $w \in K$ iff $q \in F$ is some accepting state of \mathcal{B} . The automaton \mathcal{A} moves left all the way to \vdash , and starts running either M_f or M_q depending on whether $q \in F$ or not. Since \mathcal{B} is complete, it is clear that $dom(\mathcal{A}) = dom(K?f:q)$ and the output of \mathcal{A} coincides with $[M_f]$ iff the input is in K, and otherwise coincides with $[M_g]$.

- (2) **Hadamard product.** Given an input w, the constructed 2DFT \mathcal{A} first runs M_f . Instead of executing a transition $p \xrightarrow{\dashv / \gamma, +1} q$ with q a final state of M_f , it executes $p \xrightarrow{\dashv / \gamma, -1}$ reset where reset is a new state. While in the reset state, it moves all the way back to \vdash and it starts running M_g by executing reset $\xrightarrow{\vdash / \gamma', +1} q'$ if $\delta_g(q_0, \vdash) = (q', \gamma', +1)$ where δ_g is the transition function of M_g and q_0 is the initial state of M_g . The final states of \mathcal{A} are those of M_g , and its initial state is the initial state of M_f . Clearly, $\operatorname{dom}(\mathcal{A}) = \operatorname{dom}(M_f) \cap \operatorname{dom}(M_g)$ and the output of \mathcal{A} is the concatenation of the outputs of M_f and M_g .
- (3) Cauchy product. The domain of a 2DFT is a regular language, accepted by the 2DFA obtained by ignoring the outputs. Since 2DFAs are effectively equivalent to (1)DFAs, we can construct from M_f and M_g two DFAs $\mathcal{C}_f = (Q_f, \Sigma, \delta_f, s_f, F_f)$ and $\mathcal{C}_g = (Q_g, \Sigma, \delta_g, s_g, F_g)$ such that $\mathcal{L}(\mathcal{C}_f) = \mathsf{dom}(f)$ and $\mathcal{L}(\mathcal{C}_g) = \mathsf{dom}(g)$.

Now, the set K of words w having at least two factorizations $w = u_1v_1 = u_2v_2$ with $u_1, u_2 \in \mathsf{dom}(f), \ v_1, v_2 \in \mathsf{dom}(g)$ and $u_1 \neq u_2$ is also regular. This is easy since K can be written as $K = \bigcup_{p \in F_f, q \in Q_g} L_p \cdot M_{p,q} \cdot R_q$ where

- \blacksquare L_p is the set of words which admit a run in C_f from its initial state to the final state $p \in F_f$,
- $M_{p,q}$ is the set of words which admit a run in C_f from state p to some final state in F_f , and also admit a run in C_g from its initial state to state $q \in Q_g$,
- \blacksquare R_q is the set of words which admit a run in C_g from state q to some final state in F_g , and also admit a run in C_g from its initial state to some final state in F_g .

Therefore, we have $\operatorname{\mathsf{dom}}(f \boxdot g) = \operatorname{\mathsf{dom}}(f \overleftarrow{\boxdot} g) = (\operatorname{\mathsf{dom}}(f) \cdot \operatorname{\mathsf{dom}}(g)) \setminus K$ is a regular language and we construct a complete DFA $\mathcal{C} = (Q, \Sigma, \delta, q_0, F)$ which accepts this language.

- 1. From C_f , C_g and C we construct a 1NUFT \mathcal{D} such that $\mathsf{dom}(\mathcal{D}) = \mathsf{dom}(f \boxdot g)$ and on an input word $w = u \cdot v$ with $u \in \mathsf{dom}(f)$ and $v \in \mathsf{dom}(g)$ it produces the output u # v where $\# \notin \Sigma$ is a new symbol. On an input word $w \in \Sigma^*$, the transducer \mathcal{D} runs a copy of C. Simultaneously, \mathcal{D} runs a copy of C_f on some prefix u of w, copying each input letter to the output. Whenever C_f is in a final state after reading u, the transducer \mathcal{D} may non-deterministically decide to stop running C_f , to output #, and to start running C_g on the corresponding suffix v of w ($w = u \cdot v$) while copying again each input letter to the output. The transducer \mathcal{D} accepts if C accepts w and C_g accepts v. Then, we have $u \in \mathcal{L}(C_f) = \mathsf{dom}(f)$, $v \in \mathcal{L}(C_g) = \mathsf{dom}(g)$ and $w = u \cdot v \in \mathcal{L}(C) = \mathsf{dom}(f \boxdot g)$. The output produced by \mathcal{D} is u # v. The only non-deterministic choice in an accepting run of \mathcal{D} is unambiguous since a word $w \in \mathcal{L}(C) = \mathsf{dom}(f \boxdot g)$ has a unique factorization $w = u \cdot v$ with $u \in \mathsf{dom}(f)$ and $v \in \mathsf{dom}(g)$.
- 2. We construct a 2DFT \mathcal{T} which takes as input words of the form u#v with $u,v\in\Sigma^*$, runs M_f on u and then M_g on v. To do so, u is traversed in either direction depending on M_f , and the symbol # is interpreted as the right end marker \dashv . We explain how \mathcal{T} simulates a transition of M_f moving to the right of \dashv , producing some output γ and going to a state q. If q is not final, then \mathcal{T} moves to the right of # and then all the way to the end and rejects. If q is final, then \mathcal{T} stays on # (simulated by moving right and then back left), producing the output γ , but goes to the initial state of M_g instead. \mathcal{T} then runs M_g on v, interpreting # as \vdash . When M_g moves to the right of \dashv , \mathcal{T} does the same and accepts iff M_g accepts.
- 3. In a similar manner, we construct a 2DFT \mathcal{T}' which takes as input strings of the form u # v, first runs M_g on v and then runs M_f on u. Assume that M_g wants to move to the right of \dashv going to state q. If q is not final then \mathcal{T}' also moves to the right of \dashv and rejects. Otherwise, \mathcal{T}' traverses back to \vdash and runs M_f on u. When M_f wants to move to the right of # going to some state q and producing γ , \mathcal{T}' moves also to the right of # producing γ and then all the way right producing ε . After moving to the right of \dashv , it accepts if q is a final state of M_f and rejects otherwise.

We construct a 2NUFT \mathcal{A}' as the composition of \mathcal{D} and \mathcal{T} . The composition of a 1NUFT and a 2DFT is a 2NUFT [8], hence \mathcal{A}' is a 2NUFT. Moreover, $[\![\mathcal{A}']\!] = [\![f \boxdot g]\!]$. Using the equivalence of 2NUFT and 2DFT, we can convert \mathcal{A}' into an equivalent 2DFT \mathcal{A} . In a similar way, to obtain $[\![f]\!]$ $[\![f]\!]$, the 2NUFT \mathcal{B}' is obtained as a composition of \mathcal{D} and \mathcal{T}' and is then converted to an equivalent 2DFT \mathcal{B} .

(4) **Kleene-plus.** The proof is similar to case (3). First, we show that $dom(f^{\boxplus})$ is regular. Notice that if $\varepsilon \in \mathsf{dom}(f)$ then $\mathsf{dom}(f^{\boxplus}) = \emptyset$, hence we assume below that $\varepsilon \notin \mathsf{dom}(f)$. As in case (3), the language K of words w having at least two factorizations $w = u_1v_1 = u_2v_2$ with $u_1, u_2 \in \mathsf{dom}(f), v_1, v_2 \in \mathsf{dom}(f)^*$ and $u_1 \neq u_2$ is regular. Hence, $K' = \mathsf{dom}(f)^* \cdot K$ is regular and contains all words in $dom(f)^+$ having several factorizations as products of words in dom(f). We deduce that $dom(f^{\boxplus}) = dom(f)^+ \setminus K'$ is regular and we can construct a complete DFA \mathcal{C} recognizing this domain.

As in case (3), from C_f and C, we construct a 1NUFT D which takes as input w and outputs $u_1 \# u_2 \# \cdots \# u_n$ iff there is an unambiguous decomposition of w as $u_1 u_2 \cdots u_n$, with each $u_i \in$ dom(f). We then construct a 2DFT \mathcal{T} that takes as input words of the form $u_1\#u_2\#\cdots\#u_n$ with each $u_i \in \Sigma^*$ and runs M_f on each u_i from left to right, i.e., starting with u_1 and ending with u_n . The transducer \mathcal{T} interprets # as \vdash (resp. \dashv) when it is reached from the right (resp. left). The simulation by \mathcal{T} reading # of a transition of M_f moving to the right of \dashv is as in case (3), except that \mathcal{T} goes to the initial state of M_f .

The 2NUFT \mathcal{A}' is then obtained as the composition of \mathcal{D} with the 2DFT \mathcal{T} . Finally, a 2DFT \mathcal{A} equivalent to the 2NUFT \mathcal{A}' is constructed. Likewise, \mathcal{B} is obtained using the composition of \mathcal{D} with a 2DFT \mathcal{T}' that runs M_f on each factor u_i from right to left.

(5) **2-chained Kleene-plus.** As in case (4), we construct the 1NUFT \mathcal{D} which takes as input wand outputs $u_1 \# u_2 \# \cdots \# u_n$ iff there is an unambiguous decomposition of w as $u_1 u_2 \cdots u_n$, with each $u_i \in K$. We then construct a 2DFT \mathcal{D}' that takes as input words of the form $u_1\#u_2\#\cdots\#u_n$ with each $u_i\in\Sigma^*$ and produces $u_1u_2\#u_2u_3\#\cdots\#u_{n-1}u_n$. The 2NUFT \mathcal{A}' is then obtained as the composition of \mathcal{D}' with the 2DFT \mathcal{T} constructed for case (4). Finally, a 2DFT \mathcal{A} equivalent to the 2NUFT \mathcal{A}' is constructed. The output produced by \mathcal{A} is thus $\llbracket M_f \rrbracket (u_1 u_2) \cdot \llbracket M_f \rrbracket (u_2 u_3) \cdots \llbracket M_f \rrbracket (u_{n-1} u_n)$. We proceed similarly for \mathcal{B} .

2.4 **Unambiguous forest factorization**

In Section 2.6, we prove that, given a 2DFT \mathcal{A} , we can obtain an RTE C such that $[\![\mathcal{A}]\!] = [\![C]\!]$. We use the fact that any $w \in \Sigma^*$ in the domain of \mathcal{A} can be factorized unambiguously into a good rational expression. The unambiguous factorization of words in Σ^* guides the construction of the combinator expression for $[\![\mathcal{A}]\!](w)$ over Γ in an inductive way.

For rational expressions over Σ we will use the following syntax:

$$F ::= \emptyset \mid \varepsilon \mid a \mid F \cup F \mid F \cdot F \mid F^+$$

where $a \in \Sigma$. For reasons that will be clear below, we prefer to use the Kleene-plus instead of the Kleene-star, hence we also add ε explicitly in the syntax. An expression is said to be ε -free if it does not use ε .

Let $(S, \cdot, \mathbf{1}_S)$ be a *finite* monoid and $\varphi \colon \Sigma^* \to S$ be a morphism. We say that a rational expression F is φ -good (or simply good when φ is clear from the context) when

- 1. the rational expression F is unambiguous,
- **2.** for each subexpression E of F we have $\varphi(\mathcal{L}(E)) = \{s_E\}$ is a singleton set,
- **3.** for each subexpression E^+ of F we have $s_E \cdot s_E = s_E$ is an idempotent.

Notice that \emptyset cannot be used in a good expression since it does not satisfy the second condition.

Theorem 8 (Unambiguous Forest Factorization [16]). For each $s \in S$, there is an ε -free good rational expression F_s such that $\mathcal{L}(F_s) = \varphi^{-1}(s) \setminus \{\varepsilon\} \subseteq \Sigma^+$. Therefore, $G = \varepsilon \cup \bigcup_{s \in S} F_s$ is an unambiguous rational expression over Σ such that $\mathcal{L}(G) = \Sigma^*$.

Theorem 8 can be seen as an unambiguous version of Imre Simon's forest factorization theorem [17]. Its proof, which can be found in [16], follows the same lines of the recent proofs of Simon's theorem, see e.g. [9, 10].

In the rest of the section, we assume Theorem 8, and use it in obtaining an RTE corresponding to \mathcal{A} . For the purposes of this paper, we work with the transition monoid of the two-way transducer.

2.5 Transition monoid of 2NFAs

Consider a 2-way possibly non-deterministic automaton (2NFA) \mathcal{A} . Let TrM be the transition monoid of \mathcal{A} which is obtained by quotienting the free monoid $(\Sigma^*,\cdot,\varepsilon)$ by a congruence which equate words behaving alike in the underlying automaton. In a one way automaton, the canonical morphism $\operatorname{Tr}\colon \Sigma^* \to \operatorname{TrM}$ is such that $\operatorname{Tr}(w)$ consists of the set of pairs (p,q) such that there is a run from state p to state q reading w. In the case of two-way automaton, we also consider the starting side (left/right) and ending side (left/right) of the reading head while going from state p to q. Hence, an element of TrM is a set X of tuples (p,d,q) with $p,q\in Q$ states of \mathcal{A} and $d\in\{\to,\supset,\subset,\leftarrow\}$ a direction amongst "left-left" (\supset) , "left-right" (\to) , "right-left" (\leftarrow) and "right-right" (\subset) .

In the case of two-way automata, the canonical morphism $\operatorname{Tr}\colon \Sigma^* \to \operatorname{TrM}$ is such that $\operatorname{Tr}(w)$ is the set of triples (p,d,q) which are compatible with w. For instance, $(p,\to,q)\in\operatorname{Tr}(w)$ iff $\mathcal A$ has a run starting in state p on the left of w and which exits w on its right and in state q. Likewise, $(p,\varsigma,q)\in\operatorname{Tr}(w)$ iff $\mathcal A$ has a run starting in state p on the right of w and which exits w on its right and in state q. The explanation is similar for other directions. It is well-known that TrM is a monoid and that Tr is a morphism.

Consider the 2DFT \mathcal{A} on the left of Figure 1 and its underlying input 2DFA \mathcal{B} . In the transition monoid of \mathcal{B} , we have $\mathsf{Tr}(abb) = \{(q_1, \searrow, q_5), (q_1, \subsetneq, q_2), (q_2, \searrow, q_4), (q_2, \leftarrow, q_5), (q_3, \searrow, q_4), (q_3, \leftarrow, q_5), (q_4, \searrow, q_4), (q_5, \searrow, q_5), (q_5, \subsetneq, q_6), (q_6, \rightarrow, q_2), (q_6, \subsetneq, q_1)\}.$




Figure 3 The first and second pictures are illustrations of subsets of $\operatorname{Tr}(w_1)$ and $\operatorname{Tr}(w_2)$ respectively. $(p, \to, q_1), (q_2, \varsigma, q_3), (q_4, \varsigma, q_5) \in \operatorname{Tr}(w_1)$ while $(q_1, \varsigma, q_2), (q_3, \varsigma, q_4), (q_5, \to, q) \in \operatorname{Tr}(w_2)$. The third picture shows that $(p, \to, q) \in \operatorname{Tr}(w_1 \cdot w_2)$: (p, \to, q) consists of "steps" $(p, \to, q_1), (q_1, \varsigma, q_2), (q_2, \varsigma, q_3), (q_3, \varsigma, q_4), (q_4, \varsigma, q_5), (q_5, \to, q)$ alternately from $\operatorname{Tr}(w_1)$ and $\operatorname{Tr}(w_2)$.

Let $(p,d,q) \in \mathsf{Tr}(w)$. If $w=a \in \Sigma$, then we know that reading a in state p, \mathcal{A} may move in direction d and enter state q. If $w=w_1 \cdot w_2$ for $w_1, w_2 \in \Sigma^+$, then we can possibly decompose (p,d,q) into several "steps" depending on the behaviour of \mathcal{A} on w starting in state p. As an example, see Figure 3, where we decompose $(p,\to,q) \in \mathsf{Tr}(w)$. We show only those elements of $\mathsf{Tr}(w_1)$ and $\mathsf{Tr}(w_2)$ which help in the decomposition; the pictorial depiction is visually intuitive.

Example 9. Let $\Sigma = \{a, b\}$ and let \mathcal{A} be the following 1DFT: q_1

Let TrM be the transition monoid of \mathcal{A} and let Tr: $\Sigma^* \to \text{TrM}$ be the canonical morphism. The expression $F = a^+(ba)^+$ is not Tr-good: one of the reasons why F is not Tr-good is that the subexpression a^+ is such that Tr(a) is not an idempotent; the same is true for the subexpression $(ba)^+$. The expression $F' = aba \cup aaba \cup a(aa)^+ba \cup a(baba)^+ \cup a(aa)^+(baba)^+$ is not Tr-good, even though each of the expressions aba, aaba, $a(aa)^+ba$, $a(baba)^+$ and $a(aa)^+(baba)^+$ are Tr-good. F' is not Tr-good since $\text{Tr}(\mathcal{L}(F'))$ is not a singleton. The expression $F'' = aba \cup (aa)^+ \cup a(aa)^+ba$ is Tr-good.

2.6 2DFT to RTE

Consider a deterministic and complete 2-way transducer \mathcal{A} . Let TrM be the transition monoid of the underlying input automaton. We can apply the unambiguous factorization theorem to the morphism Tr: $\Sigma^* \to \mathsf{TrM}$ in order to obtain, for each $s \in \mathsf{TrM}$, an ε -free good rational expression F_s for $\mathsf{Tr}^{-1}(s) \setminus \{\varepsilon\}$. We use the unambiguous expression $G = \varepsilon \cup \bigcup_{s \in \mathsf{TrM}} F_s$ as a guide when constructing RTEs corresponding to the 2DFT \mathcal{A} .

Lemma 10. Let F be an ε -free Tr-good rational expression and let $Tr(F) = s_F$ be the corresponding element of the transition monoid TrM of A. We can construct a map $C_F \colon s_F \to RTE$ such that for each step $x = (p, d, q) \in s_F$ the following invariants hold:

 (I_1) dom $(C_F(x)) = \mathcal{L}(F)$,

(1₂) for each $u \in \mathcal{L}(F)$, $[\![C_F(x)]\!](u)$ is the output produced by \mathcal{A} when running step x on u (i.e., running \mathcal{A} on u from p to q following direction d).

Proof. The proof is by structural induction on the rational expression. For each subexpression E of F we let $Tr(E) = s_E$ be the corresponding element of the transition monoid TrM of A. We start with atomic regular expressions. Since F is ε -free and \emptyset -free, we do not need to consider $E = \varepsilon$ or $E = \emptyset$.

atomic Assume that $E = a \in \Sigma$ is an atomic subexpression. Since the 2DFT \mathcal{A} is deterministic and complete, for each state $p \in Q$ we have

- either $\delta(p,a)=(q,\gamma,1)$ and we let $C_a((p,\rightarrow,q))=C_a((p,\varsigma,q))=a?\gamma:\bot$,
- \bullet or $\delta(p,a)=(q,\gamma,-1)$ and we let $C_a((p,\triangleright,q))=C_a((p,\leftarrow,q))=a?\gamma:\bot$.

Clearly, invariants (I_1) and (I_2) hold for all $x \in Tr(a) = s_E$.

Union Assume that $E = E_1 \cup E_2$. Since the expression is good, we deduce that $s_E = s_{E_1} = s_{E_2}$. For each $x \in s_E$ we define $C_E(x) = E_1 ? C_{E_1}(x) : C_{E_2}(x)$. Since E is unambiguous we have $\mathcal{L}(E_1) \cap \mathcal{L}(E_2) = \emptyset$. Using (I_1) for E_1 and E_2 , we deduce that

$$\mathsf{dom}(C_E(x)) = (\mathcal{L}(E_1) \cap \mathsf{dom}(C_{E_1}(x))) \cup (\mathsf{dom}(C_{E_2}(x)) \setminus \mathcal{L}(E_1)) = \mathcal{L}(E_1) \cup \mathcal{L}(E_2) = \mathcal{L}(E) \,.$$

Therefore, (I_1) holds for E. Now, for each $u \in \mathcal{L}(E)$, either $u \in \mathcal{L}(E_1)$ and $[\![C_E(x)]\!](u) = [\![C_{E_1}(x)]\!](u)$ or $u \in \mathcal{L}(E_2)$ and $[\![C_E(x)]\!](u) = [\![C_{E_2}(x)]\!](u)$. In both cases, applying (I_2) for E_1 or E_2 , we deduce that $[\![C_E(x)]\!](u)$ is the output produced by \mathcal{A} when running step x on u.

concatenation Assume that $E = E_1 \cdot E_2$ is a concatenation. Since the expression is good, we deduce that $s_E = s_{E_1} \cdot s_{E_2}$. Let $x \in s_E$.

■ If $x=(p,\to,q)$ then, by definition of the product in the transition monoid TrM, there is a unique sequence of steps $x_1=(p,\to,q_1),\ x_2=(q_1,\searrow,q_2),\ x_3=(q_2,\subsetneq,q_3),\ x_4=(q_3,\supsetneq,q_4),\ \ldots,\ x_i=(q_{i-1},\subsetneq,q_i),\ x_{i+1}=(q_i,\to,q)$ with $i\geq 1,\ x_1,x_3,\ldots,x_i\in s_{E_1}$ and $x_2,x_4,\ldots,x_{i+1}\in s_{E_2}$ (see Figure 3). We define

$$C_E(x) = (C_{E_1}(x_1) \odot C_{E_2}(x_2)) \odot (C_{E_1}(x_3) \odot C_{E_2}(x_4)) \odot \cdots \odot (C_{E_1}(x_i) \odot C_{E_2}(x_{i+1})).$$

Notice that when i=1 we simply have $C_E(x)=C_{E_1}(x_1)\boxdot C_{E_2}(x_2)$ with $x_2=(q_1,\to,q)$. The concatenation $\mathcal{L}(E)=\mathcal{L}(E_1)\cdot\mathcal{L}(E_2)$ is unambiguous. Therefore, for all $y\in s_{E_1}$ and $z\in s_{E_2}$, using (I_1) for E_1 and E_2 , we obtain $\mathsf{dom}(C_{E_1}(y)\boxdot C_{E_2}(z))=\mathcal{L}(E)$. We deduce that $\mathsf{dom}(C_E(x))=\mathcal{L}(E)$ and (I_1) holds for E.

Now, let $u \in \mathcal{L}(E)$ and let $u = u_1u_2$ be its unique factorization with $u_1 \in \mathcal{L}(E_1)$ and $u_2 \in \mathcal{L}(E_2)$. The step $x = (p, \to, q)$ performed by \mathcal{A} on u is actually the concatenation of steps x_1 on u_1 , followed by x_2 on u_2 , followed by x_3 on u_1 , followed by x_4 on u_2, \ldots , until x_{i+1} on u_2 . Using (I_2) for E_1 and E_2 , we deduce that the output produced by \mathcal{A} while running step x on u is

$$[\![C_{E_1}(x_1)]\!](u_1) \cdot [\![C_{E_2}(x_2)]\!](u_2) \cdots [\![C_{E_1}(x_i)]\!](u_1) \cdot [\![C_{E_2}(x_{i+1})]\!](u_2) = [\![C_{E}(x)]\!](u).$$

■ If $x = (p, \triangleright, q)$ then, following the definition of the product in the transition monoid TrM, we distinguish two cases.

Either $x \in s_{E_1}$ and we let $C_E(x) = C_{E_1}(x) \boxdot (E_2?\varepsilon:\bot)$. Since $\mathsf{dom}(E_2?\varepsilon:\bot) = \mathcal{L}(E_2)$, we deduce as above that $\mathsf{dom}(C_E(x)) = \mathcal{L}(E)$. Moreover, let $u \in \mathcal{L}(E)$ and $u = u_1u_2$ be its unique factorization with $u_1 \in \mathcal{L}(E_1)$ and $u_2 \in \mathcal{L}(E_2)$. The step $x = (p, \searrow, q)$ performed by \mathcal{A} on u reduces to the step x on u_1 . Using (l_2) for E_1 , we deduce that the output produced by \mathcal{A} while making step x on u is $[\![C_{E_1}(x)]\!](u_1) = [\![C_E(x)]\!](u)$.




Figure 4 Let $w = w_1 \cdot w_2 \in \mathcal{L}(E)$ with $w_1 \in \mathcal{L}(E_1)$, $w_2 \in \mathcal{L}(E_2)$. We have $(p, \rightarrow, q_1), (q_2, \varsigma, q_3), (q_4, \leftarrow, q) \in \mathsf{Tr}(w_1)$ and $(q_1, \supset, q_2), (q_3, \supset, q_4) \in \mathsf{Tr}(w_2)$. Then (p, \supset, q) is composed of "steps" $(p, \rightarrow, q_1), (q_1, \supset, q_2), (q_2, \varsigma, q_3), (q_3, \supset, q_4), (q_4, \leftarrow, q)$ alternately from $\mathsf{Tr}(w_1)$ and $\mathsf{Tr}(w_2)$.

Or there is a unique sequence of steps (see Figure 4) $x_1 = (p, \to, q_1), x_2 = (q_1, \searrow, q_2), x_3 = (q_2, \subsetneq, q_3), x_4 = (q_3, \searrow, q_4), \ldots, x_i = (q_{i-1}, \leftarrow, q)$ with $i \ge 3, x_1, x_3, \ldots, x_i \in s_{E_1}$ and $x_2, x_4, \ldots, x_{i-1} \in s_{E_2}$. We define

$$C_E(x) = (C_{E_1}(x_1) \odot C_{E_2}(x_2)) \odot (C_{E_1}(x_3) \odot C_{E_2}(x_4)) \odot \cdots \odot (C_{E_1}(x_i) \odot (E_2?\varepsilon:\bot)).$$

As for the first item, we can prove that invariants (I_1) and (I_2) are satisfied for E.




Figure 5 Let $w = w_1 \cdot w_2 \in \mathcal{L}(E)$ with $w_1 \in \mathcal{L}(E_1), w_2 \in \mathcal{L}(E_2)$. We have $(p, \leftarrow, q_1), (q_2, \supset$ $(q_1, q_2) \in \mathsf{Tr}(w_2)$ and $(q_1, q_2), (q_3, q_2), (q_3, q_2) \in \mathsf{Tr}(w_1)$. Then $(p, q_2) \in \mathsf{Tr}(w)$ is composed of "steps" $(p,\leftarrow,q_1),(q_1,\varsigma,q_2),(q_2,\varsigma,q_3),(q_3,\leftarrow,q)$ alternately from $\mathsf{Tr}(w_2)$ and $\mathsf{Tr}(w_1)$.

The cases $x=(p,\leftarrow,q)$ or $x=(p,\varsigma,q)$ are handled symmetrically. For instance, when $x=(p,\leftarrow,q)$, the unique sequence of steps is $x_1=(p,\leftarrow,q_1),\ x_2=(q_1,\varsigma,q_2),\ x_3=(q_2,\varsigma,q_3),\ x_4=(q_3,\varsigma,q_4),\ \ldots,\ x_i=(q_{i-1},\varsigma,q_i),\ x_{i+1}=(q_i,\leftarrow,q)$ with $i\geq 1,\ x_1,x_3,\ldots,x_i\in s_{E_2}$ and $x_2,x_4,\ldots,x_{i+1}\in s_{E_1}$ (see Figure 5). We define

$$C_E(x) = ((E_1?\varepsilon:\bot) \boxdot C_{E_2}(x_1)) \odot (C_{E_1}(x_2) \boxdot C_{E_2}(x_3)) \odot \cdots \odot (C_{E_1}(x_{i-1}) \boxdot C_{E_2}(x_i)) \odot (C_{E_1}(x_{i+1}) \boxdot (E_2?\varepsilon:\bot)).$$

Kleene-plus Assume that $E = F^+$. Since the expression is good, we deduce that $s_E = s_F = s$ is an idempotent of the transition monoid TrM. Let $x \in s$.

If $x = (p, \supset, q)$. Since F^+ is unambiguous, a word $u \in \mathcal{L}(F^+)$ admits a unique factorization $u = u_1 u_2 \cdots u_n$ with $n \geq 1$ and $u_i \in \mathcal{L}(F)$. Now, $Tr(u_1) = s_E$ and since $x = (p, \supset, q) \in s_E$ the unique run ρ of \mathcal{A} starting in state p on the left of u_1 exits on the left in state q.




Figure 6 In the Kleene-plus $E = F^+$, a step $x = (p, \rightarrow, q) \in s_E$ on some $u = u_1 u_2 \cdots u_n$ with $u_{\ell} \in \mathcal{L}(F)$ is obtained by composing the following steps in s_F : $x_1 = x$, $x_2 = (q, \geq, p_2)$, $x_3 = (p_2, <, p_3)$, $x_4 = (p_3, \geqslant, p_4), x_5 = (p_4, \varsigma, p_5), x_6 = (p_5, \rightarrow, q).$

Therefore, the unique run of A starting in state p on the left of $u = u_1 u_2 \cdots u_n$ only visits u_1 and is actually ρ itself. Therefore, we set $C_E(x) = C_F(x) \odot (F^*?\varepsilon:\bot)$ and we can easily check that (I_1-I_2) are satisfied.

- \blacksquare Similarly for $x = (p, \zeta, q)$ we set $C_E(x) = (F^*? \varepsilon : \bot) \boxdot C_F(x)$.
- If $x = (p, \rightarrow, q)$. Recall that s is an idempotent, hence $x \in s^2$. We distinguish two cases. Either $y = (q, \rightarrow, q) \in s$ and we set $C_E(x) = F ? C_F(x) : (C_F(x) \boxdot (C_F(y))^{\boxplus})$. Or there exists a unique sequence of steps in s: $x_1 = x$, $x_2 = (q, \geq, p_2)$, $x_3 = (p_2, \leq, p_3)$, $x_4 = (p_3, \geq, p_4), \ldots, x_i = (p_{i-1}, \leq, p_i), x_{i+1} = (p_i, \rightarrow, q) \text{ with } i \geq 3 \text{ (see Figure 6)}.$ We define

$$C_E(x) = (C_F(x) \boxdot (F^*?\varepsilon:\bot)) \odot [F,C']^{2\boxplus}$$

$$C' = ((F?\varepsilon:\bot) \boxdot C_F(x_2)) \odot (C_F(x_3) \boxdot C_F(x_4)) \odot \cdots \odot (C_F(x_i) \boxdot C_F(x_{i+1}))$$

Since the expression is good, the Kleene-plus $E = F^+$ is unambiguous. We have $dom(C_F(x_i)) =$ $\mathcal{L}(F)$ for $1 \leq j \leq i+1$ by (I_1) . Also $\mathsf{dom}(F^*?\varepsilon:\bot) = \mathcal{L}(F^*)$. Since F^+ is unambiguous, the concatenation $F \cdot F^*$ is also unambiguous and we get $\mathsf{dom}(C_F(x) \boxdot (F^*?\varepsilon : \bot)) =$ $\mathcal{L}(F) \cdot \mathcal{L}(F^*) = \mathcal{L}(E)$. Also, the product $F \cdot F$ is unambiguous and we deduce that

 $\operatorname{dom}(C_F(x_j) \boxdot C_F(x_{j+1})) = \mathcal{L}(F)^2$ for $1 \leq j \leq i$ and $\operatorname{dom}((F?\varepsilon:\bot) \boxdot C_F(x_2)) = \mathcal{L}(F)^2$. Therefore, $\operatorname{dom}(C') = \mathcal{L}(F)^2$ and using once again that F^+ is unambiguous, we deduce that $\operatorname{dom}([F,C']^{2\boxplus}) = \mathcal{L}(F^+) = \mathcal{L}(E)$. We deduce that $\operatorname{dom}(C_E(x)) = \mathcal{L}(E)$ and (I_1) holds for E.

Let now $u \in \mathcal{L}(F^+) = \mathsf{dom}(C_E(x))$. We have to show that the output $\gamma \in \mathbb{D}$ produced by \mathcal{A} when running step x on u is $\llbracket C_E(x) \rrbracket (u)$. There is a unique factorization $u = u_1 u_2 \cdots u_n$ with $n \geq 1$ and $u_\ell \in \mathcal{L}(F)$ for $1 \leq \ell \leq n$.

Assume first that n=1 (see Figure 6 left). By definition, we have $\llbracket [F,C']^{2\mathbb{H}} \rrbracket(u) = \varepsilon$ and $\llbracket C_F(x) \boxdot (F^*?\varepsilon:\bot) \rrbracket(u) = \llbracket C_F(x) \rrbracket(u)$ which, by induction, is the output γ produced by \mathcal{A} running step x on u. Therefore, $\llbracket C_E(x) \rrbracket(u) = \gamma \cdot \varepsilon = \gamma$.

Assume now that $n \geq 2$ (see Figure 6 middle for n=2 and right for n=5). For $1 \leq \ell \leq n$ and $1 \leq j \leq i+1$, we denote $\gamma_j^\ell = [\![C_F(x_j)]\!](u_\ell)$ the output produced by $\mathcal A$ when running step x_j on u_ℓ . We can check (see Figure 6) that the output γ produced by $\mathcal A$ when running x on $u = u_1 u_2 \cdots u_n$ is

$$\gamma = \gamma_1^1 (\gamma_2^2 \gamma_3^1 \gamma_4^2 \cdots \gamma_i^1 \gamma_{i+1}^2) (\gamma_2^3 \gamma_3^2 \gamma_4^3 \cdots \gamma_i^2 \gamma_{i+1}^3) \cdots (\gamma_2^n \gamma_3^{n-1} \gamma_4^n \cdots \gamma_i^{n-1} \gamma_{i+1}^n) \,.$$

We have $[\![C']\!](u_\ell u_{\ell+1}) = \gamma_2^{\ell+1} \gamma_3^\ell \gamma_4^{\ell+1} \cdots \gamma_i^\ell \gamma_{i+1}^{\ell+1}$ for $1 \leq \ell < n$. Therefore, we obtain $\gamma = \gamma_1^1 [\![C']\!](u_1 u_2) [\![C']\!](u_2 u_3) \cdots [\![C']\!](u_{n-1} u_n)$. Since $[\![C_F(x) \boxdot (F^*?\varepsilon : \bot)]\!](u) = \gamma_1^1$ we deduce that $\gamma = [\![C_E(x)]\!](u)$.

The case of $x = (p, \leftarrow, q)$ can be handled similarly.

Lemma 10 is the main ingredient in the construction of an RTE equivalent to a 2DFT.

Proof of Theorem 6(2). First, we let $C_{\varepsilon} = \llbracket \mathcal{A} \rrbracket(\varepsilon) \in \Gamma^* \cup \{\bot\}$. Then, we will define for each $s \in \mathsf{TrM}$, an RTE C_s such that $\mathsf{dom}(C_s) = \mathsf{dom}(\mathcal{A}) \cap (\mathsf{Tr}^{-1}(s) \setminus \{\varepsilon\})$ and $\llbracket C_s \rrbracket(u) = \llbracket \mathcal{A} \rrbracket(u)$ for all $u \in \mathsf{dom}(C_s)$. Assuming an arbitrary enumeration s_1, s_2, \ldots, s_m of TrM, we define the final RTE as

$$C_{\mathcal{A}} = \varepsilon \, ? \, C_{\varepsilon} : \left(\mathsf{Tr}^{-1}(s_1) \, ? \, C_{s_1} : \left(\mathsf{Tr}^{-1}(s_2) \, ? \, C_{s_2} : \cdots \left(\mathsf{Tr}^{-1}(s_{m-1}) \, ? \, C_{s_{m-1}} : C_{s_m} \right) \right) \right).$$

It remains to define the RTE C_s for $s \in \text{TrM}$. We first define RTEs for steps in the 2DFT \mathcal{A} on some input $\vdash u$ with $u \in \text{Tr}^{-1}(s) \setminus \{\varepsilon\}$. Such a step must exit on the right since there are no transitions of \mathcal{A} going left when reading \vdash . So either the step (q_0, \to, q) starts on the left in the initial state q_0 and exits on the right in some state q. Or the step (p, ς, q) starts on the right in state p and exits on the right in state q. See Figure 7.


Let s_{\vdash} be the set of steps $(p, \rightarrow, q), (p, \varsigma, q)$ such that there is a transition $\delta(p, \vdash) = (q, \gamma_p, +1)$ in \mathcal{A} . From the initial state q_0 of \mathcal{A} , there is a unique sequence of steps $x_1 = (q_0, \rightarrow, q_1),$ $x_2 = (q_1, \searrow, q_2), x_3 = (q_2, \varsigma, q_3), x_4 = (q_3, \searrow, q_4), \ldots, x_i = (q_{i-1}, \varsigma, q_i), x_{i+1} = (q_i, \rightarrow, q)$ with $i \geq 1, x_1, x_3, \ldots, x_i \in s_{\vdash}$ and $x_2, x_4, \ldots, x_{i+1} \in s$ (see Figure 7 left). We define

$$C_{\vdash F_s}((q_0, \rightarrow, q)) = \gamma_{q_0} \odot C_{F_s}(x_2) \odot \gamma_{q_2} \odot C_{F_s}(x_4) \odot \cdots \odot \gamma_{q_{i-1}} \odot C_{F_s}(x_{i+1}).$$

Notice that when i=1 we simply have $C_{\vdash F_s}((q_0, \to, q)) = \gamma_{q_0} \odot C_{F_s}((q_1, \to, q))$. Since $\mathsf{dom}(C_{F_s}(x_i)) = \mathcal{L}(F_s) = \mathsf{Tr}^{-1}(s) \setminus \{\varepsilon\}$ for $i=2,4,\ldots,i+1$, we deduce that $\mathsf{dom}(C_{\vdash F_s}((q_0, \to, q))) = \mathsf{Tr}^{-1}(s) \setminus \{\varepsilon\}$. Moreover, for each $u \in \mathsf{Tr}^{-1}(s) \setminus \{\varepsilon\}$, the output produced by \mathcal{A} performing step (q_0, \to, q) on $\vdash u$ is $[\![C_{\vdash F_s}((q_0, \to, q))]\!](u)$.

Let p be a state of \mathcal{A} . Either there is a step $(p, \zeta, q) \in s$ and we let $C_{\vdash F_s}((p, \zeta, q)) = C_{F_s}((p, \zeta, q))$. Or, there is a unique sequence of steps $x_1 = (p, \leftarrow, q_1), \ x_2 = (q_1, \zeta, q_2), \ x_3 = (q_2, \zeta, q_3), \ x_4 = (q_3, \zeta, q_4), \ldots, x_i = (q_{i-1}, \rightarrow, q)$ with $i \geq 3, \ x_1, x_3, \ldots, x_i \in s$ and $x_2, x_4, \ldots, x_{i-1} \in s_{\vdash}$ (see Figure 7 right). We define

$$C_{\vdash F_s}((p, \varsigma, q)) = C_{F_s}(x_1) \odot \gamma_{q_1} \odot C_{F_s}(x_3) \odot \gamma_{q_3} \odot \cdots \odot \gamma_{q_{i-2}} \odot C_{F_s}(x_i).$$







As above, we have $\operatorname{\mathsf{dom}}(C_{\vdash F_s}((p,\varsigma,q))) = \operatorname{\mathsf{Tr}}^{-1}(s) \setminus \{\varepsilon\}$. Moreover, for each $u \in \operatorname{\mathsf{Tr}}^{-1}(s) \setminus \{\varepsilon\}$, the output produced by \mathcal{A} performing step (p,ς,q) on $\vdash u$ is $\llbracket C_{\vdash F_s}((p,\varsigma,q)) \rrbracket(u)$.

Similarly, let s_{\dashv} be the set of steps (p, \supset, q) such that there is a transition $\delta(p, \dashv) = (q, \gamma_p, -1)$ in \mathcal{A} or (p, \rightarrow, q) such that there is a transition $\delta(p, \dashv) = (q, \gamma_p, +1)$ in \mathcal{A} . From the initial state q_0 of \mathcal{A} , there is a unique sequence of steps $x_1 = (q_0, \rightarrow, q_1), \ x_2 = (q_1, \supset, q_2), \ x_3 = (q_2, \subset, q_3), \ x_4 = (q_3, \supset, q_4), \dots, x_i = (q_{i-1}, \subset, q_i), \ x_{i+1} = (q_i, \rightarrow, q) \text{ with } i \geq 1, \text{ and } x_1, x_3, \dots, x_i \text{ are steps}$ where $C_{\vdash F_s}$ is defined and $x_2, x_4, \dots, x_{i+1} \in s_{\dashv}$ (see Figure 8).

Notice that this sequence of steps corresponds to an accepting run iff $q \in F$ is an accepting state of \mathcal{A} . Therefore, either $q \notin F$ and $dom(\mathcal{A}) \cap (Tr^{-1}(s) \setminus \{\varepsilon\}) = \emptyset$ so we set $C_s = \bot$. Or, $q \in F$ and $Tr^{-1}(s) \setminus \{\varepsilon\} \subseteq dom(\mathcal{A})$ so we define

$$C_s = C_{\vdash F_s}(x_1) \odot \gamma_{q_1} \odot C_{\vdash F_s}(x_3) \odot \gamma_{q_3} \odot \cdots \odot C_{\vdash F_s}(x_i) \odot \gamma_{q_i}$$
.

We have $dom(C_s) = Tr^{-1}(s) \setminus \{\varepsilon\}$ and for all $u \in dom(C_s)$ we have $\llbracket C_s \rrbracket(u) = \llbracket \mathcal{A} \rrbracket(u)$.

3 Infinite Words

In this section, we start looking at regular functions on infinite words. As in Section 2, we restrict our attention to two way transducers as the model for computing regular functions. Given a finite alphabet Σ , let Σ^{ω} denote the set of infinite words over Σ , and let $\Sigma^{\infty} = \Sigma^* \cup \Sigma^{\omega}$ be the set of all finite or infinite words over Σ .

3.1 Two-way transducers over ω -words (ω -2DMTla)

Let Σ be a finite input alphabet and let Γ be a finite output alphabet. Let \vdash be a left end marker symbol not in Σ and let $\Sigma_{\vdash} = \Sigma \cup \{\vdash\}$. The input word is presented as $\vdash w$ where $w \in \Sigma^{\omega}$.

Let \mathcal{R} be a finite set of look-ahead ω -regular languages. For the ω -regular languages in \mathcal{R} , we may use any finite descriptions such as ω -regular expressions or automata. Below, we will use complete unambiguous Büchi automata (CUBA) [7], also called backward deterministic Büchi automata [18]). A deterministic two-way transducer (ω -2DMTIa) over ω -words is given by $\mathcal{A} = (Q, \Sigma, \Gamma, q_0, \delta, \mathcal{F}, \mathcal{R})$, where Q is a finite set of states, $q_0 \in Q$ is a unique initial state, and

 $\delta \colon Q \times \Sigma_{\vdash} \times \mathcal{R} \mapsto Q \times \Gamma^* \times \{-1, +1\}$ is the partial transition function. We request that for every pair $(q, a) \in Q \times \Sigma_{\vdash}$, the subset $\mathcal{R}(q, a)$ of languages $R \in \mathcal{R}$ such that $\delta(q, a, R)$ is defined forms a partition of Σ^{ω} . This ensures that \mathcal{A} is complete and behaves deterministically. The set $\mathcal{F} \subseteq 2^Q$ specifies the Muller acceptance condition. As in the finite case, the reading head cannot move left while on \vdash . A configuration is represented by w'qaw'' where $w'a \in \vdash \Sigma^*$, $w'' \in \Sigma^{\omega}$ and q is the current state, scanning letter a. From configuration w'qaw'', let R be the unique ω -regular language in $\mathcal{R}(q, a)$ such that $w'' \in R$, the automaton outputs γ and moves to

$$\begin{cases} w'aq'w'' & \text{if } \delta(q,a,R) = (q',\gamma,+1) \\ w'_1q'baw'' & \text{if } \delta(q,a,R) = (q',\gamma,-1) \text{ and } w' = w'_1b \,. \end{cases}$$

The output $\gamma \in \Gamma^*$ is appended at the end of the output produced so far. A run ρ of \mathcal{A} on $w \in \Sigma^{\omega}$ is a sequence of transitions starting from the initial configuration $q_0 \vdash w$ where the reading head is on \vdash :

$$q_0 \vdash w \xrightarrow{\gamma_1} w_1' q_1 w_1'' \xrightarrow{\gamma_2} w_2' q_2 w_2'' \xrightarrow{\gamma_3} w_3' q_3 w_3'' \xrightarrow{\gamma_4} w_4' q_4 w_4'' \cdots$$

We say that ρ reads the whole word w if $\sup\{|w'_n| \mid n>0\} = \infty$. The set of states visited by ρ infinitely often is denoted $\inf(\rho) \subseteq Q$. The word w is accepted by \mathcal{A} , i.e., $w \in \mathsf{dom}(\mathcal{A})$ if ρ reads the whole word w and $\inf(\rho) \in \mathcal{F}$ is a Muller set. In this case, we let $[\![\mathcal{A}]\!](w) = \gamma_1 \gamma_2 \gamma_3 \gamma_4 \cdots$ be the output produced by ρ .

The notation ω -2DMTla signifies the use of the look-ahead (la) using the ω -regular languages in \mathcal{R} . It must be noted that without look-ahead, the expressive power of two-way transducers over infinite words is lesser than regular transformations over infinite words [4]. A classical example of this is given in Example 11, where the look-ahead is necessary to obtain the required transformation.

Example 11. On the right of Figure 1 we have an ω -2DMTla \mathcal{A}' over $\Sigma = \{a, b, \#\}$ that defines the transformation $[\![\mathcal{A}']\!](u_1\#u_2\#\cdots\#u_n\#v) = u_1^Ru_1\#u_2^Ru_2\#\cdots\#u_n^Ru_n\#v$ where $u_1,\ldots,u_n\in(a+b)^*$, $v\in(a+b)^\omega$ and u^R denotes the reverse of u. The Muller acceptance set is $\{\{q_5\}\}$. From state q_1 reading \vdash , or state q_4 reading #, \mathcal{A}' uses the look ahead partition $\mathcal{R}(q_1,\vdash) = \mathcal{R}(q_4,\#) = \{\Sigma^*\#\Sigma^\omega, (\Sigma\setminus\{\#\})^\omega\}$, which indicates the presence or absence of a # in the remaining suffix of the word being read. For all other transitions, the look-ahead langage is Σ^ω , hence it is omitted. Also, to keep the picture light, the automaton is not complete, i.e., we have omitted the transitions going to a sink state. It can be seen that any maximal string u between two consecutive occurrences of # is replaced with u^Ru ; the infinite suffix over $\{a,b\}^\omega$ is then reproduced as it is.

Remark. Note that, an equivalent way to define ω -2DMTIa is using look-behind and look-ahead automata [4] instead of ω -regular languages in \mathcal{R} . See Appendix B for a proof of equivalence.

3.2 ω -Regular Transducer Expressions (ω -RTE)

As in the case of finite words, we define regular transducer expressions for infinite words. Let Σ and Γ be finite input and output alphabets and let \bot stand for undefined. We define the output domain as $\mathbb{D} = \Gamma^{\infty} \cup \{\bot\}$, with the usual concatenation of a finite word on the left with a finite or infinite word on the right. Again, \bot acts as zero and the unit is the empty word $1_{\mathbb{D}} = \varepsilon$.

The syntax of ω -Regular Transducer Expressions (ω -RTE) from Σ^{ω} to \mathbb{D} is defined by:

$$C ::= L?C : C \mid C \odot C \mid E \boxdot C \mid E^{\omega} \mid [K, E]^{2\omega}$$

where $K \subseteq \Sigma^+$ ranges over regular languages of finite non-empty words, $L \subseteq \Sigma^\omega$ ranges over ω -regular languages of infinite words and E is an RTE over finite words as defined in Section 2.2. The semantics $[\![E]\!]: \Sigma^* \to \Gamma^* \cup \{\bot\}$ of the finitary combinator expressions $E \in \mathsf{RTE}$ is unchanged (see Section 2.2). The semantics of an ω -RTE C is a function $[\![C]\!]: \Sigma^\omega \to \mathbb{D}$. Given a regular

language $K \subseteq \Sigma^+$, an ω -regular language $L \subseteq \Sigma^\omega$, and functions $f : \Sigma^* \to \Gamma^* \cup \{\bot\}, g, h : \Sigma^\omega \to \mathbb{D}$, we define

If then else. We have $dom(L?g:h) = (dom(g) \cap L) \cup (dom(h) \setminus L)$.

Moreover, (L?q:h)(w) is defined as q(w) for $w \in \mathsf{dom}(q) \cap L$, and h(w) for $w \in \mathsf{dom}(h) \setminus L$. **Hadamard product.** We have $dom(g \odot h) = g^{-1}(\Gamma^*) \cap dom(h)$.

Moreover, $(g \odot h)(w) = g(w) \cdot h(w)$ for $w \in \mathsf{dom}(g) \cap \mathsf{dom}(h)$ with $g(w) \in \Gamma^*$.

Unambiguous Cauchy product. If $w \in \Sigma^{\omega}$ admits a unique factorization $w = u \cdot v$ with $u \in \Sigma^{\omega}$ dom(f) and $v \in dom(g)$ then we set $(f \odot g)(w) = f(u) \cdot g(v)$. Otherwise, we set $(f \odot g)(w) = \bot$.

Unambiguous ω -iteration. If $w \in \Sigma^{\omega}$ admits a unique infinite factorization $w = u_1 u_2 u_3 \cdots$ with $u_i \in \mathsf{dom}(f)$ for all $i \geq 1$ then we set $f^{\omega}(w) = f(u_1)f(u_2)f(u_3)\cdots \in \Gamma^{\infty}$. Otherwise, we set $f^{\omega}(w) = \bot$.

Unambiguous 2-chained ω -iteration. If $w \in \Sigma^{\omega}$ admits a unique factorization $w = u_1 u_2 u_3 \cdots$ with $u_i \in K$ for all $i \geq 1$ and if moreover $u_i u_{i+1} \in \mathsf{dom}(f)$ for all $i \geq 1$ then we set $[K, f]^{2\omega}(w) = f(u_1u_2)f(u_2u_3)f(u_3u_4)\cdots$. Otherwise, we set $[K, f]^{2\omega}(w) = \bot$.

Remark. Let $C_{\varepsilon} = (\Sigma ? \varepsilon : \bot)^{\omega}$. We have $\operatorname{dom}(C_{\varepsilon}) = \Sigma^{\omega}$ and $[\![C_{\varepsilon}]\!](w) = \varepsilon$ for all $w \in \Sigma^{\omega}$. Now, for $\gamma \in \Gamma^+$, let $C_{\gamma} = (\Sigma ? \gamma : \bot) \supseteq C_{\varepsilon}$. We have $\mathsf{dom}(C_{\gamma}) = \Sigma^{\omega}$ and $[\![C_{\gamma}]\!](w) = \gamma$ for all $w \in \Sigma^{\omega}$. Therefore, we can freely use constants $\gamma \in \Gamma^*$ when defining ω -RTEs.

Remark. We can express the ω -iteration with the 2-chained ω -iteration as follows: $f^{\omega} = [\mathsf{dom}(f), f \odot (\mathsf{dom}(f)?\varepsilon : \bot)]^{2\omega}.$

Example 12. We now give the ω -RTE for the transformation given in Example 11.

Let $E_1 = a?a: (b?b: (\#?\#: \bot)), E_2 = a?a: (b?b: \bot) \text{ and } E_3 = a?a: (b?b: (\#?\varepsilon: \bot)).$

Then $dom(E_1) = dom(E_3) = (a+b+\#)$ and $dom(E_2) = (a+b)$. Let $E_4 = ((a+b)^*\#)? (E_3^{\boxplus} \odot E_1^{\boxplus}): \bot$. We have $dom(E_4) = (a+b)^*\#$ and, for $u \in (a+b)^*$, $\llbracket E_4 \rrbracket (u\#) = u^R u\#$ where u^R denotes the reverse of u. Next, let $C_1 = E_4^{\boxplus} \boxdot E_2^{\omega}$. Then, $dom(C_1) = [(a+b)^* \#]^+ (a+b)^\omega$, and $[C_1](u_1 \# u_2 \# \cdots u_n \# v) = u_1^R u_1 \# u_2^R u_2 \# \cdots \# u_n^R u_n \# v$ when $u_i \in (a+b)^*$ and $v \in (a+b)^\omega$. Finally, let $C = (a+b)^\omega$? $E_2^\omega : C_1$. We have $\mathsf{dom}(C) =$ $[(a+b)^*\#]^*(a+b)^\omega$ and [C] = [A'] where A' is the transducer on the right of Figure 1.

The main theorem connecting ω -2DMTla and ω -RTE is as follows.

Theorem 13. ω -2DMTIa and ω -RTEs define the same class of functions. More precisely,

- 1. given an ω -RTE C, we can construct an ω -2DMTla \mathcal{A} such that [A] = [C].
- 2. given an ω -2DMTIa \mathcal{A} , we can construct an ω -RTE C such that [A] = [C],

The proof of (1) is given in the next section, while the proof of (2) will be given in Section 3.7 after some preparatory work on backward deterministic Büchi automata (Section 3.4) which are used to remove the look-ahead of ω -2DMTIa (Section 3.5), and the notion of transition monoid for ω -2DMTla (Section 3.6) used in the unambiguous forest factorization theorem extended to infinite words (Theorem 20).

3.3 ω-RTE to ω-2DMTla

In this section, we prove one direction of Theorem 13: given an ω -RTE C, we can construct an ω -2DMTIa \mathcal{A} such that $[\![\mathcal{A}]\!] = [\![\mathcal{C}]\!]$. The proof is by structural induction and follows immediately from

Lemma 14. Let $K \subseteq \Sigma^*$ be regular and $L \subseteq \Sigma^{\omega}$ be ω -regular. Let f be an RTE with $[\![f]\!] = [\![M_f]\!]$ for some 2DFT M_f . Let g,h be ω -RTEs with $\llbracket g \rrbracket = \llbracket M_g \rrbracket$ and $\llbracket h \rrbracket = \llbracket M_h \rrbracket$ for ω -2DMTla M_g and M_h respectively. Then, one can construct

- 1. an ω -2DMTIa \mathcal{A} such that $[L?q:h] = [\mathcal{A}]$,
- **2.** an ω -2DMTIa \mathcal{A} such that $[A] = [q \odot h]$.
- 3. an ω -2DMTIa \mathcal{A} such that $[\![\mathcal{A}]\!] = [\![g \boxdot h]\!]$,
- **4.** an ω -2DMTIa \mathcal{A} such that $[\![\mathcal{A}]\!] = [\![f^{\omega}]\!]$,
- **5.** an ω -2DMTIa \mathcal{A} such that $[\![\mathcal{A}]\!] = [\![[K,f]^{2\omega}]\!]$.

Proof. Throughout the proof, we let $M_g = (Q_g, \Sigma, \Gamma, s_g, \delta_g \mathcal{F}_g, \mathcal{R}_g)$ and $M_h = (Q_h, \Sigma, \Gamma, s_h, \delta_h, \mathcal{F}_h, \mathcal{R}_h)$ be the bethe ω -2DMTIa such that $\llbracket M_g \rrbracket = \llbracket g \rrbracket$ and $\llbracket M_h \rrbracket = \llbracket h \rrbracket$.

- (1) If then else. The set of states of A is $Q_A = \{q_0\} \cup Q_g \cup Q_h$ with $q_0 \notin Q_g \cup Q_h$. In state q_0 , we have the transitions $\delta_{\mathcal{A}}(q_0,(\vdash,R\cap L))=(q,\gamma,+1)$ if $\delta_g(s_g,(\vdash,R))=(q,\gamma,+1)$ and $\delta_{\mathcal{A}}(q_0,(\vdash,R'\setminus L))=(q',\gamma',+1)$ if $\delta_h(s_h,(\vdash,R'))=(q',\gamma',+1)$. This invokes M_g (M_h) iff the input w is in L (not in L). The Muller set \mathcal{F} is simply a union $\mathcal{F}_g \cup \mathcal{F}_h$ of the respective Muller sets of M_q and M_h . It is clear that [A] coincides with $[M_q]$ iff the input string is in L, and otherwise, [A] coincides with $[M_h]$.
- (2) **Hadamard product.** We create a look ahead which indicates the position where we can stop reading the input word w for the transducer M_q . The look ahead should satisfy two conditions for this purpose:
- \blacksquare We cannot visit any position to the left of the current position in the remaining run of M_q on w.
- The output produced by running M_g on the suffix should be ε .

To accommodate these two conditions, we create look ahead automata A_q for each state $q \in Q_q$ and let $L_q = dom(A_q)$. The structure of A_q is same as M_q except that we

- add a new initial state ι_q and the transition $\delta_q(\iota_q, \vdash, \Sigma^\omega) = (q, \varepsilon, +1),$
- \blacksquare remove all transitions from M_g where the output is $\gamma \neq \varepsilon$,
- \blacksquare remove all transitions from M_g where the input symbol is \vdash .

We explain the construction of the ω -2DMTla \mathcal{A} such that $\llbracket g \odot h \rrbracket = \llbracket \mathcal{A} \rrbracket$. The set of states of \mathcal{A} are $Q_A = Q_g \cup Q_h \cup \{\text{reset}\}$. Backward transitions in A and M_g are same: $\delta_A(q, a, R) = (q', \gamma, -1)$ iff $\delta_q(q, a, R) = (q', \gamma, -1)$. Forward transitions of M_q are divided into two depending on the look ahead. If we have $\delta_q(q, a, R) = (q', \gamma, +1)$ in M_q for an $a \in \Sigma_{\vdash}$, then

$$\delta_{\mathcal{A}}(q, a, R \setminus L_{q'}) = (q', \gamma, +1)$$
 and $\delta_{\mathcal{A}}(q, a, R \cap L_{q'}) = (\mathsf{reset}, \gamma, +1).$

From the reset state, we go to the left until \vdash is reached and then start running M_h . So, $\delta_{\mathcal{A}}(\mathsf{reset}, a, \Sigma^{\omega}) = (\mathsf{reset}, \varepsilon, -1) \text{ for all } a \in \Sigma \text{ and } \delta_{\mathcal{A}}(\mathsf{reset}, \vdash, R) = (q'', \gamma, +1) \text{ if } \delta_h(s_h, \vdash, R) = (q$ $(q'', \gamma, +1)$. The accepting set is same as the Muller accepting set \mathcal{F}_h of M_h .

(3) Cauchy product. From the transducers M_f and M_g , we can construct a DFA $\mathcal{D}_f =$ $(Q_f, \Sigma, \delta_f, s_f, F_f)$ that accepts $dom(M_f)$ and a deterministic Muller automaton (DMA) $\mathcal{D}_q =$ $(Q_g, \Sigma, \delta_g, s_g, \mathcal{F}_g)$ that accepts $dom(M_g)$.

Now, the set L of words w having at least two factorizations $w = u_1v_1 = u_2v_2$ with $u_1, u_2 \in$ $dom(f), v_1, v_2 \in dom(g)$ and $u_1 \neq u_2$ is ω -regular. This is easy since L can be written as $L = \bigcup_{p \in F_f, q \in Q_g} L_p \cdot M_{p,q} \cdot R_q \text{ where}$ $\blacksquare L_p \subseteq \Sigma^* \text{ is the regular set of words which admit a run in } \mathcal{D}_f \text{ from its initial state to state } p,$

- $M_{p,q} \subseteq \Sigma^*$ is the regular set of words which admit a run in \mathcal{D}_f from state p to some final state in \mathcal{D}_f , and also admit a run in \mathcal{D}_g from the initial state to some state q in \mathcal{D}_g ,
- \blacksquare $R_q \subseteq \Sigma^{\omega}$ is the ω -regular set of words which (i) admit an accepting run from state q in \mathcal{D}_g and also (ii) admit an accepting run in \mathcal{D}_q from its initial state s_q .

Therefore, $dom(f \odot g) = (dom(f) \cdot dom(g)) \setminus L$ is ω -regular.

First we construct an ω -1DMTla \mathcal{D} such that $\mathsf{dom}(\mathcal{D}) = \mathsf{dom}(f \odot q)$ and on an input word w = uv with $u \in \mathsf{dom}(f)$ and $v \in \mathsf{dom}(g)$, it produces the output u # v where $\# \notin \Sigma$ is a new symbol. From its initial state while reading \vdash , \mathcal{D} uses the look-ahead to check whether the input word w is in $dom(f \Box g)$ or not. If yes, it moves right and enters the initial state of \mathcal{D}_f . If not, it goes to a sink state and rejects. While running \mathcal{D}_f , \mathcal{D} copies each input letter to output. Upon reaching a final state of \mathcal{D}_f , we use the look-ahead $\mathsf{dom}(g)$ to see whether we should continue running \mathcal{D}_f or we should switch to \mathcal{D}_g . Formally, if $\delta_f(q, a) = q' \in F_f$ the corresponding transitions of \mathcal{D} are

 $\delta_{\mathcal{D}}(q, a, \mathsf{dom}(g)) = (s_g, a\#, +1)$ and $\delta_{\mathcal{D}}(q, a, \Sigma^{\omega} \setminus \mathsf{dom}(g)) = (q', a, +1).$ While running \mathcal{D}_g , \mathcal{D} copies each input letter to output. Accepting sets of \mathcal{D} are the accepting sets of the DMA \mathcal{D}_g . Thus, \mathcal{D} produces an output u#v for an input string w = uv which is in $\mathsf{dom}(f \boxdot g)$ such that $u \in \mathsf{dom}(f)$ and $v \in \mathsf{dom}(g)$.

Next we construct an ω -2DMTla \mathcal{T} which takes input words of the form u#v with $u\in\Sigma^*$ and $v\in\Sigma^\omega$, runs M_f on u and M_g on v. To do so, u is traversed in either direction depending on M_f and the symbol # is interpreted as right end marker \dashv for M_f . While simulating a transition of M_f moving right of \dashv , producing the output γ and reaching state q, there are two possibilities. If q is not a final state of M_f then \mathcal{T} moves to the right of #, goes to some sink state and rejects. If q is a final state of M_f , then \mathcal{T} stays on # producing the output γ and goes to the initial state of M_g . Then, \mathcal{T} runs M_g on v interpreting # as \vdash . The Muller accepting set of \mathcal{T} is same as M_g .

We construct an ω -2DMTla \mathcal{A} as the composition of \mathcal{D} and \mathcal{T} . Regular transformations are definable by ω -2DMTla [4] and are closed under composition [11]. Thus the composition of an ω -1DMTla and an ω -2DMTla is an ω -2DMTla. We deduce that \mathcal{A} is an ω -2DMTla. Moreover $\|\mathcal{A}\| = \|f \odot g\|$.

- (4) ω -iteration. By the remark above Example 12, this is a derived operator and hence the result follows from the next case.
- (5) **2-chained** ω -iteration. First we show that the set of words w in Σ^{ω} having an unambiguous decomposition $w = u_1 u_2 \cdots$ with $u_i \in K$ for each i is ω -regular. As in case (3) above, the language L of words w having at least two factorizations $w = u_1 v_1 = u_2 v_2$ with $u_1, u_2 \in K$, $v_1, v_2 \in K^{\omega}$ and $u_1 \neq u_2$ is ω -regular. Hence, $L' = K^* \cdot L$ is ω -regular and contains all words in Σ^{ω} having several factorizations as products of words in K. We deduce that $\Sigma^{\omega} \setminus L'$ is ω -regular.

As in case (3) above, we construct an ω -1DMTla \mathcal{D} which takes as input w and outputs $u_1 \# u_2 \# \cdots$ iff there is an unambiguous decomposition of w as $u_1 u_2 \cdots$ with each $u_i \in K$. We then construct an ω -2DMT \mathcal{D}' that takes as input words of the form $u_1 \# u_2 \# \cdots$ with each $u_i \in \Sigma^*$ and produces $u_1 u_2 \# u_2 u_3 \# \cdots$.

Next we construct an ω -2DMT \mathcal{T} that takes as input words of the form $w_1 \# w_2 \# \cdots$ with each $w_i \in \Sigma^*$ and runs M_f on each w_i from left to right. The transducer \mathcal{T} interprets # as \vdash (resp. \dashv) when it is reached from the right (resp. from left). While simulating a transition of M_f moving right of \dashv , we proceed as in case (3) above, except that \mathcal{T} goes to the initial state of M_f instead.

The ω -2DMTIa \mathcal{A} is then obtained as the composition of \mathcal{D} , \mathcal{D}' and \mathcal{T} . The output produced by \mathcal{A} is thus $\llbracket M_f \rrbracket (u_1 u_2) \llbracket M_f \rrbracket (u_2 u_3) \cdots$.

3.4 Backward deterministic Büchi automata (BDBA)


A Büchi automaton over the input alphabet Σ is a tuple $\mathcal{B} = (P, \Sigma, \Delta, \mathsf{Fin})$ where P is a finite set of states, $\mathsf{Fin} \subseteq P$ is the set of final (accepting) states, and $\Delta \subseteq P \times \Sigma \times P$ is the transition relation. A run of \mathcal{B} over an infinite word $w = a_1 a_2 a_3 \cdots$ is a sequence $\rho = p_0, a_1, p_1, a_2, p_2, \ldots$ such that $(p_{i-1}, a_i, p_i) \in \Delta$ for all $i \geq 1$. The run is final (accepting) if $\mathsf{inf}(\rho) \cap \mathsf{Fin} \neq \emptyset$ where $\mathsf{inf}(\rho)$ is the set of states visited infinitely often by ρ .

The Büchi automaton \mathcal{B} is backward deterministic (BDBA) or complete unambiguous (CUBA) if for all infinite words $w \in \Sigma^{\omega}$, there is exactly one run ρ of \mathcal{B} over w which is final, this run is denoted $\mathcal{B}(w)$. The fact that we request at least/most one final run on w explains why the automaton is called complete/unambiguous. Wlog, we may assume that all states of \mathcal{B} are useful, i.e., for all $p \in P$ there exists some $w \in \Sigma^{\omega}$ such that $\mathcal{B}(w)$ starts from state p. In that case,

it is easy to check that the transition relation is backward deterministic and complete: for all $(p,a) \in P \times \Sigma$ there is exactly one state p' such that $(p',a,p) \in \Delta$. We write $p' \stackrel{a}{\leftarrow} p$ and state p' is denoted $\Delta^{-1}(p,a)$. In other words, the inverse of the transition relation $\Delta^{-1}: P \times \Sigma \to P$ is a total function.

For each state $p \in P$, we let $\mathcal{L}(\mathcal{B}, p)$ be the set of infinite words $w \in \Sigma^{\omega}$ such that $\mathcal{B}(w)$ starts from p. For every subset $I \subseteq P$ of initial states, the language $\mathcal{L}(\mathcal{B}, I) = \bigcup_{p \in I} \mathcal{L}(\mathcal{B}, p)$ is ω -regular.

Example 15. For instance, the automaton \mathcal{B} below is a BDBA. Morover, we have $\mathcal{L}(\mathcal{B}, p_2) = (\Sigma \setminus \{\#\})^{\omega}$, $\mathcal{L}(\mathcal{B}, p_4) = (\#\Sigma^*)^{\omega}$, and $\mathcal{L}(\mathcal{B}, \{p_1, p_3, p_4\}) = \Sigma^* \#\Sigma^{\omega}$.



Deterministic Büchi automata (DBA) are strictly weaker than non-deterministic Büchi automata (NBA) but backward determinism keeps the full expressive power.

Theorem 16 (Carton & Michel [7]). A language $L \subseteq \Sigma^{\omega}$ is ω -regular iff $L = \mathcal{L}(\mathcal{B}, I)$ for some BDBA \mathcal{B} and initial set I.

The proof in [7] is constructive, starting with an NBA with m states, they construct an equivalent BDBA with $(3m)^m$ states.

A crucial fact on BDBA is that they are easily closed under boolean operations. In particular, the complement, which is quite difficult for NBAs, becomes trivial with BDBAs: $\mathcal{L}(\mathcal{B}, P \setminus I) = \Sigma^{\omega} \setminus \mathcal{L}(\mathcal{B}, I)$. For intersection and union, we simply use the classical cartesian product of two automata \mathcal{B}_1 and \mathcal{B}_2 . This clearly preserves the backward determinism. For intersection, we use a generalized Büchi acceptance condition, i.e., a conjunction of Büchi acceptance conditions. For BDBAs, generalized and classical Büchi acceptance conditions are equivalent [7]. We obtain immediately


Corollary 17. Let \mathcal{R} be a finite family of ω -regular languages. There is a BDBA \mathcal{B} and a tuple of initial sets $(I_R)_{R\in\mathcal{R}}$ such that $R=\mathcal{L}(\mathcal{B},I_R)$ for all $R\in\mathcal{R}$.

3.5 Replacing the look-ahead of an ω -2DMTla with a BDBA

Let $\mathcal{A}=(Q,\Sigma,\Gamma,q_0,\delta,\mathcal{F},\mathcal{R})$ be an ω -2DMTIa. By Corollary 17 there is a BDBA $\mathcal{B}=(P,\Sigma,\Delta,\mathsf{Fin})$ and a tuple $(I_R)_{R\in\mathcal{R}}$ of initial sets for the finite family \mathcal{R} of ω -regular languages used as lookahead by the automaton \mathcal{A} . Recall that for every pair $(q,a)\in Q\times\Sigma_{\vdash}$, the subset $\mathcal{R}(q,a)$ of languages $R\in\mathcal{R}$ such that $\delta(q,a,R)$ is defined forms a partition of Σ^{ω} . We deduce that $(I_R)_{R\in\mathcal{R}(q,a)}$ is a partition of P.

We construct an ω -2DMT $\widetilde{\mathcal{A}} = (Q, \widetilde{\Sigma}, \Gamma, q_0, \widetilde{\delta}, \mathcal{F})$ without look-ahead over the extended alphabet $\widetilde{\Sigma} = \Sigma \times P$ which is equivalent to \mathcal{A} in some sense made precise below. Intuitively, in a pair $(a, p) \in \widetilde{\Sigma}_{\vdash}$, the state p of \mathcal{B} gives the look-ahead information required by \mathcal{A} . Formally, the deterministic transition function $\widetilde{\delta} \colon Q \times \widetilde{\Sigma_{\vdash}} \to Q \times \Gamma^* \times \{-1, +1\}$ is defined as follows: for $q \in Q$ and $(a, p) \in \widetilde{\Sigma_{\vdash}}$ we let $\widetilde{\delta}(q, (a, p)) = \delta(q, a, R)$ for the unique $R \in \mathcal{R}(q, a)$ such that $p \in I_R$.

Example 18. For instance, the automaton $\widetilde{\mathcal{A}}$ constructed from the automaton on the right of Figure 1 and the BDBA \mathcal{B} of Example 15 is depicted below, where \bullet stands for an arbitrary state of \mathcal{B} .



Let $w = a_1 a_2 a_3 \cdots \in \Sigma^{\omega}$ and let $\mathcal{B}(w) = p_0, a_1, p_1, a_2, p_2, \ldots$ be the unique final run of \mathcal{B} on w. We define $Fw = (\vdash, p_0)(a_1, p_1)(a_2, p_2) \cdots \in \widetilde{\Sigma_{\vdash}}^{\omega}$. We can easily check by induction that the unique run of \mathcal{A} on w

$$q_0 \vdash w \xrightarrow{\gamma_1} w_1' q_1 w_1'' \xrightarrow{\gamma_2} w_2' q_2 w_2'' \xrightarrow{\gamma_3} w_3' q_3 w_3'' \xrightarrow{\gamma_4} w_4' q_4 w_4'' \cdots$$

corresponds to the unique run of $\widetilde{\mathcal{A}}$ on $\widetilde{\vdash w}$

$$q_0\widetilde{\vdash w} \xrightarrow{\gamma_1} \widetilde{w_1'} q_1 \widetilde{w_1''} \xrightarrow{\gamma_2} \widetilde{w_2'} q_2 \widetilde{w_2''} \xrightarrow{\gamma_3} \widetilde{w_3'} q_3 \widetilde{w_3''} \xrightarrow{\gamma_4} \widetilde{w_4'} q_4 \widetilde{w_4''} \cdots$$

where for all i > 0 we have $\widetilde{\vdash} w = \widetilde{w_i'}\widetilde{w_i''}$ and $|w_i'| = |\widetilde{w_i'}|$. Indeed, assume that in a configuration w'qaw'' with $\vdash w = w'aw''$ the transducer \mathcal{A} takes the transition $q \xrightarrow{(a,R)} (q',\gamma,\pm 1)$ and reaches configuration w'aq'w''. Then, $w'' \in R$ and the corresponding configuration $\widetilde{w'}q(a,p)\widetilde{w''}$ with $\widetilde{\vdash} w = \widetilde{w'}(a,p)\widetilde{w''}$ and $|w'| = |\widetilde{w'}|$ is such that $p \in I_R$. Therefore, the transducer $\widetilde{\mathcal{A}}$ takes the transition $q \xrightarrow{(a,p)} (q',\gamma,\pm 1)$ and reaches configuration $\widetilde{w'}(a,p)q'\widetilde{w''}$. The proof is similar for backward transitions. We have shown that \mathcal{A} and $\widetilde{\mathcal{A}}$ are equivalent in the following sense:

Lemma 19. For all words $w \in \Sigma^{\omega}$, the transducer A starting from $\vdash w$ accepts iff the transducer \widetilde{A} starting from $\vdash w$ accepts, and in this case they compute the same output in Γ^{∞} .

3.6 Transition monoid of an ω -2DMTla

We use the notations of the previous sections, in particular for the ω -2DMTla \mathcal{A} , the BDBA \mathcal{B} and the corresponding ω -2DMT $\widetilde{\mathcal{A}}$. As in the case of 2NFAs over finite words, we will define a congruence on Σ^+ such that two words $u, v \in \Sigma^+$ are equivalent iff they behave the same in the ω -2DMTla \mathcal{A} , when placed in an arbitrary right context $w \in \Sigma^{\omega}$. The right context w is abstracted with the first state p of the unique final run $\mathcal{B}(w)$.

The ω -2DMT $\widetilde{\mathcal{A}}$ does not use look-ahead, hence, we may use for $\widetilde{\mathcal{A}}$ the classical notion of transition monoid. Actually, in order to handle the Muller acceptance condition of $\widetilde{\mathcal{A}}$, we need a slight extension of the transition monoid defined in Section 2.5. More precisely, the abstraction of a finite word $\widetilde{u} \in \widetilde{\Sigma}^+$ will be the set $\widetilde{\operatorname{Tr}}(\widetilde{u})$ of tuples (q,d,X,q') with $q,q' \in Q, X \subseteq Q$ and $d \in \{\to, \supset, \subset, \leftarrow\}$ such that the unique run of $\widetilde{\mathcal{A}}$ on \widetilde{u} starting in state q on the left of \widetilde{u} if $d \in \{\to, \supset\}$ (resp. on the right if $d \in \{\subset, \leftarrow\}$) exits in state q' on the left of \widetilde{u} if $d \in \{\supset, \leftarrow\}$ (resp. on the right if $d \in \{\to, \subset\}$) and visits the set of states X while in \widetilde{u} (i.e., including q but not q' unless q' is also visited before the run exits \widetilde{u}).

For instance, with the automaton $\widetilde{\mathcal{A}}$ of Example 18, we have $(q_4, \rightarrow, \{q_2, q_3, q_4\}, q_5) \in \widetilde{\mathsf{Tr}}(\widetilde{u})$ when $\widetilde{u} \in ((a, p_1) + (b, p_1))^*(\#, p_1)((a, p_1) + (b, p_1))^*(\#, p_2)$.

We denote by $\widetilde{\mathsf{TrM}} = \{\widetilde{\mathsf{Tr}}(\widetilde{u}) \mid \widetilde{u} \in \widetilde{\Sigma}^+\} \cup \{\mathbf{1}_{\widetilde{\mathsf{TrM}}}\}\$ the transition monoid of $\widetilde{\mathcal{A}}$ with unit $\mathbf{1}_{\widetilde{\mathsf{TrM}}}$. The classical product is extended by taking the union of the sets X occurring in a sequence

of steps. For instance, if we have steps (q_0, \to, X_1, q_1) , $(q_2, \varsigma, X_3, q_3)$, ..., $(q_{i-1}, \varsigma, X_i, q_i)$ in $\widetilde{\mathsf{Tr}}(\widetilde{u})$ and $(q_1, \varsigma, X_2, q_2)$, $(q_3, \varsigma, X_4, q_4)$, ..., $(q_i, \to, X_{i+1}, q_{i+1})$ in $\widetilde{\mathsf{Tr}}(\widetilde{v})$ then there is a step $(q_0, \to, X_1 \cup \cdots \cup X_{i+1}, q_{i+1})$ in $\widetilde{\mathsf{Tr}}(\widetilde{u} \cdot \widetilde{v}) = \widetilde{\mathsf{Tr}}(\widetilde{u}) \cdot \widetilde{\mathsf{Tr}}(\widetilde{v})$. We denote by $\widetilde{\mathsf{Tr}} : \widetilde{\Sigma}^* \to \widetilde{\mathsf{TrM}}$ the canonical morphism.

Let $u = a_1 \cdots a_n \in \Sigma^+$ be a finite word of length n > 0 and let $p \in P$. We define the sequence of states p_0, p_1, \ldots, p_n by $p_n = p$ and for all $0 \le i < n$ we have $p_i \xleftarrow{a_{i+1}} p_{i+1}$ in \mathcal{B} . Notice that for all infinite words $w \in \mathcal{L}(\mathcal{B}, p)$, the unique run $\mathcal{B}(uw)$ starts with $p_0, a_1, p_1, \ldots, a_n, p_n$. We define $\widetilde{u}^p = (a_1, p_1)(a_2, p_2) \cdots (a_n, p_n) \in \widetilde{\Sigma}^+$.

We are now ready to define the finite abstraction $\mathsf{Tr}(u)$ of a finite word $u \in \Sigma^+$ with respect to the pair $(\mathcal{A}, \mathcal{B})$: we let $\mathsf{Tr}(u) = (r^p, b^p, s^p)_{p \in P}$ where for each $p \in P$, $s^p = \widetilde{\mathsf{Tr}}(\widetilde{u}^p) \in \widetilde{\mathsf{TrM}}$ is the abstraction of \widetilde{u}^p with respect to $\widetilde{\mathcal{A}}$, $r^p \in P$ is the unique state of \mathcal{B} such that $r^p \stackrel{\iota}{\leftarrow} p$, $b^p = 1$ if the word \widetilde{u}^p contains a final state of \mathcal{B} and $b^p = 0$ otherwise.

The transition monoid of $(\mathcal{A},\mathcal{B})$ is the set $\mathsf{TrM} = \{\mathsf{Tr}(u) \mid u \in \Sigma^+\} \cup \{\mathsf{1}_{\mathsf{TrM}}\}$ where $\mathsf{1}_{\mathsf{TrM}}$ is the unit. The product of $\sigma_1 = (r_1^p, b_1^p, s_1^p)_{p \in P}$ and $\sigma = (r^p, b^p, s^p)_{p \in P}$ is defined to be $\sigma_1 \cdot \sigma = (r_1^{r^p}, b_1^{r^p} \vee b^p, s_1^{r^p} \cdot s^p)_{p \in P}$. We can check that this product is associative, so that $(\mathsf{TrM}, \cdot, \mathsf{1}_{\mathsf{TrM}})$ is a monoid. Moreover, let $u, v \in \Sigma^+$ be such that $\mathsf{Tr}(u) = \sigma_1$ and $\mathsf{Tr}(v) = \sigma$. For each $p \in P$, we can check that $\widetilde{uv}^p = \widetilde{u}^{r^p} \cdot \widetilde{v}^p$. We deduce easily that $\mathsf{Tr}(uv) = \sigma_1 \cdot \sigma = \mathsf{Tr}(u) \cdot \mathsf{Tr}(v)$. Therefore, $\mathsf{Tr} \colon \Sigma^* \to \mathsf{TrM}$ is a morphism.

3.7 ω -2DMTla to ω -RTE

We prove in this section that from an ω -2DMTIa \mathcal{A} we can construct an equivalent ω -RTE. The proof follows the ideas already used for finite words in Section 2.6. We will use the following generalization to infinite words of the unambiguous forest factorization Theorem 8.

Theorem 20 (Unambiguous Forest Factorization [16]). Let $\varphi \colon \Sigma^* \to S$ be a morphism to a finite monoid $(S,\cdot,\mathbf{1}_S)$. There is an unambiguous rational expression $G = \bigcup_{k=1}^m F_k \cdot G_k^{\omega}$ over Σ such that $\mathcal{L}(G) = \Sigma^{\omega}$ and for all $1 \le k \le m$ the expressions F_k and G_k are ε -free φ -good rational expressions and s_{G_k} is an idempotent, where $\varphi(G_k) = \{s_{G_k}\}$.

We will apply this theorem to the morphism $\operatorname{Tr} \colon \Sigma^* \to \operatorname{TrM}$ defined in Section 3.6. We use the unambiguous expression $G = \bigcup_{k=1}^m F_k \cdot G_k^{\omega}$ as a *guide* when constructing ω -RTEs corresponding to the ω -2DMTla \mathcal{A} .

Lemma 21. Let G be an ε -free Tr-good rational expression and let $\operatorname{Tr}(G) = \sigma_G = (r_G^p, b_G^p, s_G^p)_{p \in P}$ be the corresponding element of the transition monoid TrM of $(\mathcal{A}, \mathcal{B})$. For each state $p \in P$, we can construct a map $C_G^p \colon s_G^p \to RTE$ such that for each step $x = (q, d, X, q') \in s_G^p$ the following invariants hold:

- $(\mathsf{J}_1) \ \mathsf{dom}(C_G^p(x)) = \mathcal{L}(G),$
- (J_2) for each $u \in \mathcal{L}(G)$, $[\![C_G^p(x)]\!](u)$ is the output produced by $\widetilde{\mathcal{A}}$ when running step x on \widetilde{u}^p (i.e., running $\widetilde{\mathcal{A}}$ on \widetilde{u}^p from q to q' following direction d).

Proof. The proof is by structural induction on the rational expression. For each subexpression E of G we let $\text{Tr}(E) = \sigma_E = (r_E^p, b_E^p, s_E^p)_{p \in P}$ be the corresponding element of the transition monoid TrM of $(\mathcal{A}, \mathcal{B})$. We start with atomic regular expressions. Since G is ε -free and \emptyset -free, we do not need to consider $E = \varepsilon$ or $E = \emptyset$. The construction is similar to the one given in Section 2.6. The interesting cases are concatenation and Kleene-plus.

atomic Assume that $E=a\in \Sigma$ is an atomic subexpression. Notice that $\widetilde{a}^p=(a,p)$ for all $p\in P$. Since the ω -2DMT $\widetilde{\mathcal{A}}$ is deterministic and complete, for each state $q\in Q$ we have = either $\widetilde{\delta}(q,(a,p))=(q',\gamma,1)$ and we let $C^p_a((q,\rightarrow,\{q\},q'))=C^p_a((q,\subset,\{q\},q'))=a?\gamma:\bot$, = or $\widetilde{\delta}(q,(a,p))=(q',\gamma,-1)$ and we let $C^p_a((q,\supset,\{q\},q'))=C^p_a((q,\leftarrow,\{q\},q'))=a?\gamma:\bot$. Clearly, invariants (J_1) and (J_2) hold for all $x\in s^p_E$.

Union Assume that $E = E_1 \cup E_2$. Since E is good, we deduce that $\sigma_E = \sigma_{E_1} = \sigma_{E_2}$. For each $p \in P$ and $x \in s_E^p$ we define $C_E^p(x) = E_1 ? C_{E_1}^p(x) : C_{E_2}^p(x)$. Since E is unambiguous we have $\mathcal{L}(E_1) \cap \mathcal{L}(E_2) = \emptyset$. As in Section 2.6 we can prove easily that invariants (J_1) and (J_2) hold for all $x \in s_E^p$.

concatenation Assume that $E = E_1 \cdot E_2$ is a concatenation. Since E is good, we deduce that $\sigma_E = \sigma_{E_1} \cdot \sigma_{E_2}$. Let $p \in P$ and $p_1 = r_{E_2}^p$. We have $s_E^p = s_{E_1}^{p_1} \cdot s_{E_2}^p$. Let $x \in s_E^p$.

If $x = (q, \to, X, q')$ then, by definition of the product in the transition monoid $\overline{\text{rM}}$, there is a unique sequence of steps $x_1 = (q, \to, X_1, q_1), \ x_2 = (q_1, \supset, X_2, q_2), \ x_3 = (q_2, \subset, X_3, q_3), \ x_4 = (q_3, \supset, X_4, q_4), \dots, \ x_i = (q_{i-1}, \subset, X_i, q_i), \ x_{i+1} = (q_i, \to, X_{i+1}, q') \text{ with } i \geq 1, \ x_1, x_3, \dots, x_i \in s_{E_1}^{p_1} \text{ and } x_2, x_4, \dots, x_{i+1} \in s_{E_2}^{p_2} \text{ and } X = X_1 \cup \dots \cup X_{i+1} \text{ (see Figure 9 top left). We define$

$$C_E^p(x) = (C_{E_1}^{p_1}(x_1) \boxdot C_{E_2}^p(x_2)) \odot (C_{E_1}^{p_1}(x_3) \boxdot C_{E_2}^p(x_4)) \odot \cdots \odot (C_{E_1}^{p_1}(x_i) \boxdot C_{E_2}^p(x_{i+1})) \,.$$

Notice that when i=1 we have $C_E^p(x)=C_{E_1}^{p_1}(x_1)\boxdot C_{E_2}^p(x_2)$ with $x_2=(q_1,\to,X_2,q')$. The concatenation $\mathcal{L}(E)=\mathcal{L}(E_1)\cdot\mathcal{L}(E_2)$ is unambiguous. Therefore, for all $y\in s_{E_1}^{p_1}$ and $z\in s_{E_2}^p$, using (J₁) for E_1 and E_2 , we obtain $\mathsf{dom}(C_{E_1}^{p_1}(y)\boxdot C_{E_2}^p(z))=\mathcal{L}(E)$. We deduce that $\mathsf{dom}(C_E(x))=\mathcal{L}(E)$ and (J₁) holds for E and $x=(q,\to,X,q')$.

Now, let $u \in \mathcal{L}(E)$ and let $u = u_1 u_2$ be its unique factorization with $u_1 \in \mathcal{L}(E_1)$ and $u_2 \in \mathcal{L}(E_2)$. We have $\widetilde{u_1 u_2}^p = \widetilde{u_1}^{p_1} \cdot \widetilde{u_2}^p$. Hence, the step $x = (q, \to, X, q')$ performed by $\widetilde{\mathcal{A}}$ on \widetilde{u}^p is actually the concatenation of steps x_1 on $\widetilde{u_1}^{p_1}$, followed by x_2 on $\widetilde{u_2}^p$, followed by x_3 on $\widetilde{u_1}^{p_1}$, followed by x_4 on $\widetilde{u_2}^p$, ..., until x_{i+1} on $\widetilde{u_2}^p$. Using (J₂) for E_1 and E_2 , we deduce that the output produced by $\widetilde{\mathcal{A}}$ while making step x on \widetilde{u}^p is

$$[\![C_{E_1}^{p_1}(x_1)]\!](u_1) \cdot [\![C_{E_2}^{p}(x_2)]\!](u_2) \cdots [\![C_{E_1}^{p_1}(x_i)]\!](u_1) \cdot [\![C_{E_2}^{p}(x_{i+1})]\!](u_2) = [\![C_{E}^{p}(x)]\!](u).$$

Therefore, (J_2) holds for E and step $x=(q,\to,X,q')$. The proof is obtained mutatis mutandis for the other cases $x=(q, \searrow, X, q')$ or $x=(q, \swarrow, X, q')$ or $x=(q, \leftarrow, X, q')$.

Kleene-plus Assume that $E = F^+$. Since E is good, we deduce that $\sigma_E = \sigma_F = \sigma = (r^p, b^p, s^p)_{p \in P}$ is an idempotent of the transition monoid TrM. Notice that for all $p \in P$, since σ is an idempotent, we have $r^{r^p} = r^p$.

We first define C_E^p for states $p \in P$ such that $p = r^p$. Let $x \in s^p$.

- If $x=(q, \supset, X, q')$. Since F^+ is unambiguous, a word $u\in \mathcal{L}(F^+)$ admits a unique factorization $u=u_1u_2\cdots u_n$ with $n\geq 1$ and $u_i\in \mathcal{L}(F)$. Now, $\operatorname{Tr}(u_i)=\sigma$ for all $1\leq i\leq n$ and since $p=r^p$ we deduce that $\widetilde{u}^p=\widetilde{u_1}^p\widetilde{u_2}^p\cdots \widetilde{u_n}^p$. Since $x=(q,\supset,X,q')\in s^p$, the unique run ρ of $\widetilde{\mathcal{A}}$ starting in state q on the left of $\widetilde{u_1}^p$ exits on the left in state q'. Therefore, the unique run of $\widetilde{\mathcal{A}}$ starting in state q on the left of \widetilde{u}^p only visits $\widetilde{u_1}^p$ and is actually ρ itself. Therefore, we set $C_E^p(x)=C_F^p(x) \boxdot (F^*\,?\,\varepsilon:\bot)$ and we can easily check that $(\mathsf{J_1}\mathsf{-}\mathsf{J_2})$ are satisfied.
- \blacksquare Similarly for $x=(q, \varsigma, X, q')$ we set $C_E^p(x)=(F^*\,?\,\varepsilon:\bot)\boxdot C_F^p(x).$
- If $x = (q, \to, X, q')$. Since σ is an idempotent, we have $x \in s^p \cdot s^p$. We distinguish two cases depending on whether the step $y \in s^p$ starting in state q' from the left goes to the right or goes back to the left.

First, if $y=(q',\to,X_2,q_2)\in s^p$ goes to the right. Since s^p is an idempotent, following x in $s^p\cdot s^p$ is same as following x in (the first) s^p an then y in (the second) s^p . Therefore, we must have $q_2=q'$ and $X_2\subseteq X$. In this case, we set $C_E^p(x)=F$? $C_F^p(x):\left(C_F^p(x)\boxdot(C_F^p(y))^{\boxplus}\right)$. Second, if $y=(q',\searrow,X_2,q_2)\in s^p$ goes to the left. Since s^p is an idempotent, there exists a unique sequence of steps in $s^p\colon x_1=x, x_2=y, x_3=(q_2,\subsetneq,X_3,q_3), x_4=(q_3,\supsetneq,X_4,q_4),\ldots,x_i=(q_{i-1},\subsetneq,X_i,q_i), x_{i+1}=(q_i,\to,X_{i+1},q')$ with $i\geq 3$ (see Figure 9 middle). We define

$$\begin{split} C_E^p(x) &= \left(C_F^p(x) \boxdot (F^* ? \varepsilon : \bot) \right) \odot [F, C']^{2 \boxplus} \\ C' &= \left((F ? \varepsilon : \bot) \boxdot C_F^p(x_2) \right) \odot (C_F^p(x_3) \boxdot C_F^p(x_4)) \odot \cdots \odot (C_F^p(x_i) \boxdot C_F^p(x_{i+1})) \end{split}$$

The proof of correctness, i.e., that (J_1-J_2) are satisfied for E, is as in Section 2.6.

■ If $x = (q, \leftarrow, X, q')$, the proof is obtained mutatis mutandis, using the backward unambiguous (2-chained) Kleene-plus $C^{\stackrel{\leftarrow}{\boxminus}}$ and $[K, C]^{\stackrel{\leftarrow}{2\boxplus}}$.

Now, we consider $p \in P$ with $r^p \neq p$. We let $p' = r^p$. We have already noticed that since σ is idempotent we have $r^{p'} = p'$. Consider a word $u \in \mathcal{L}(F^+)$. Since F^+ is unambiguous, u admits a unique factorization $u = u_1 \cdots u_{n-1} u_n$ with $n \geq 1$ and $u_i \in \mathcal{L}(F)$. Now, $\text{Tr}(u_i) = \sigma$ for all $1 \leq i \leq n$. Using $r^p = p'$ and $r^{p'} = p'$ we deduce that $\widetilde{u}^p = \widetilde{u_1}^{p'} \cdots \widetilde{u_{n-1}}^{p'} \widetilde{u_n}^p$. So when n > 1, the expression C_E^p that we need to compute is like the concatenation of $C_E^{p'}$ on the first n-1 factors with C_F^p on the last factor. Since $r^{p'} = p'$ we have already seen how to compute $C_E^{p'}$. We also know how to handle concatenation. So it should be no surprise that we can compute C_E^p when $p \neq r^p$. We define now formally $C_E^p(x)$ for $x \in s^p$.

If $x=(q, \supset, X, q') \in s^p$. There are two cases depending on whether the step $y \in s^{p'}$ starting in state q from the left goes back to the left or goes to the right. If it goes back to the left, then $y=(q, \supset, X, q')=x$ since $s^p=s^{p'}\cdot s^p$ (recall that σ is idempotent) and we define

$$C_E^p(x) = F ? C_E^p(x) : (C_E^{p'}(x) \odot (F^+ ? \varepsilon : \bot)).$$

If it goes to the right, then $y=(q,\rightarrow,X_1,q_1)$ and there exists a unique sequence of steps: $x_1=y,\ x_2=(q_1,\supset,X_2,q_2),\ x_3=(q_2,\subset,X_3,q_3),\ x_4=(q_3,\supset,X_4,q_4),\ \ldots,\ x_i=(q_{i-1},\leftarrow,X_i,q')$ with $i\geq 3,\ x_1,x_3,\ldots,x_i\in s^{p'}$ and $x_2,\ldots,x_{i-1}\in s^p$ (see Figure 9 top right). Notice that $X=X_1\cup\cdots\cup X_i$. We define $C_E^p(x)=F$? $C_F^p(x):C'$ where

$$C' = (C_E^{p'}(x_1) \odot C_F^p(x_2)) \odot \cdots \odot (C_E^{p'}(x_{i-2}) \odot C_F^p(x_{i-1})) \odot (C_E^{p'}(x_i) \odot (F?\varepsilon:\bot)).$$

We can check that (J_1-J_2) are satisfied for (E, p, x).

If $x = (q, \leftarrow, X, q') \in s^p$. There are two cases depending on whether the step $y \in s^{p'}$ starting in state q' from the right goes to the left or goes back to the right. If it goes to the left, then $y = (q', \leftarrow, X', q')$ with $X' \subseteq X$ and we define

$$C_E^p(x) = F ? C_F^p(x) : (C_E^{p'}(y) \stackrel{\leftarrow}{\boxdot} C_F^p(x)).$$

If it goes back to the right, then $y = (q', \zeta, X_2, q_2)$ and there exists a unique sequence of steps: $x_1 = x, x_2 = y, x_3 = (q_2, \zeta, X_3, q_3), x_4 = (q_3, \zeta, X_4, q_4), \ldots, x_i = (q_{i-1}, \zeta, X_i, q_i)$ $x_{i+1} = (q_i, \leftarrow, X_{i+1}, q')$ with $i \geq 3, x_1, x_3, \ldots, x_i \in s^p$ and $x_2, \ldots, x_{i+1} \in s^{p'}$. Notice that $X_2 \cup \cdots \cup X_{i+1} \subseteq X$. We define $C_E^p(x) = F ? C_F^p(x) : C'$ where

$$C' = (C_E^{p'}(x_2) \stackrel{\longleftarrow}{\boxdot} C_F^p(x_1)) \odot \cdots \odot (C_E^{p'}(x_{i-1}) \stackrel{\longleftarrow}{\boxdot} C_F^p(x_{i-2})) \odot (C_E^{p'}(x_{i+1}) \stackrel{\longleftarrow}{\boxdot} C_F^p(x_i)).$$

We can check that (J_1-J_2) are satisfied for (E, p, x).

The cases $x=(q,\to,X,q')\in s^p$ and $x=(q,\varsigma,X,q')\in s^p$ can be handled similarly.

We now define RTEs corresponding to the left part of the computation of the ω -2DMTla \mathcal{A} , i.e., on some input $\vdash u$ consisting of the left end-marker and some finite word $u \in \Sigma^+$. As before, the look-ahead is determined by the state of the BDBA \mathcal{B} .

Lemma 22. Let F be an ε -free Tr-good rational expression. For each state $p \in P$ and $q \in Q$, there is a unique state $q' \in Q$ and an RTE $C^p_{\vdash F}(q, \rightarrow, q')$ (resp. $C^p_{\vdash F}(q, \varsigma, q')$) such that the following invariants hold:

- $(\mathsf{K}_1) \ \mathcal{L}(F) = \mathsf{dom}(C^p_{\vdash F}(q, \rightarrow, q')) \ (\mathit{resp.} \ \mathcal{L}(F) = \mathsf{dom}(C^p_{\vdash F}(q, \varsigma, q'))),$
- (K₂) for each $u \in \mathcal{L}(F)$, $[\![C^p_{\vdash F}(q, \rightarrow, q')]\!](u)$ (resp. $[\![C^p_{\vdash F}(q, \varsigma, q')]\!](u)$) is the output produced by $\widetilde{\mathcal{A}}$ on $\widetilde{\vdash u}^p$ when starting on the left (resp. right) in state q until it exists on the right in state q'.



Proof. Let $\sigma=(r^p,b^p,s^p)_{p\in P}=\mathsf{Tr}(F)$. We fix some state $p\in P$. For all words $u\in\mathcal{L}(F)$, we have $\widetilde{\vdash u}^p=(\vdash,r^p)\widetilde{u}^p$. Let s^p_{\vdash} be the set of steps $(q,\to,q'),(q,\varsigma,q')$ such that $\widetilde{\delta}(q,(\vdash,r^p))=(q',\gamma^p_q,+1)$ in $\widetilde{\mathcal{A}}$.

For each $q \in Q$, there is a unique sequence of steps $x_1 = (q, \to, q_1), x_2 = (q_1, \searrow, X_2, q_2),$ $x_3 = (q_2, \subsetneq, q_3), x_4 = (q_3, \searrow, X_4, q_4), \ldots, x_i = (q_{i-1}, \subsetneq, q_i), x_{i+1} = (q_i, \to, X_{i+1}, q')$ with $i \ge 1$, $x_1, x_3, \ldots, x_i \in S_{\vdash}^p$ and $x_2, x_4, \ldots, x_{i+1} \in S_{\vdash}^p$ (see Figure 9 bottom left). We define

$$C^p_{\vdash F}(q, \to, q') = \gamma^p_q \odot C^p_F(x_2) \odot \gamma^p_{q_2} \odot C^p_F(x_4) \odot \cdots \odot \gamma^p_{q_{i-1}} \odot C^p_F(x_{i+1}).$$

Using Lemma 21, we can show that $\mathcal{L}(F) = \mathsf{dom}(C^p_{\vdash F}(q, \to, q'))$ and also that for each $u \in \mathcal{L}(F)$, $[\![C^p_{\vdash F}(q, \to, q')]\!](u)$ is the output produced by $\widetilde{\mathcal{A}}$ on $\widetilde{\vdash u}^p$ when starting on the left in state q until it exists on the right in state q'.

For each $q \in Q$, there is a unique sequence of steps $x_1 = (q, \leftarrow, X_1, q_1), x_2 = (q_1, \varsigma, q_2), x_3 = (q_2, \varsigma, X_3, q_3), x_4 = (q_3, \varsigma, q_4), \ldots, x_i = (q_{i-1}, \varsigma, q_i), x_{i+1} = (q_i, \rightarrow, X_{i+1}, q') \text{ with } i \geq 2, x_2, x_4, \ldots, x_i \in S^p_{\vdash} \text{ and } x_1, x_3, \ldots, x_{i+1} \in S^p$ (see Figure 9 bottom right). We define

$$C^p_{\vdash F}(q, \varsigma, q') = C^p_F(x_1) \odot \gamma^p_{q_1} \odot C^p_F(x_3) \odot \gamma^p_{q_3} \odot \cdots \odot \gamma^p_{q_{i-1}} \odot C^p_F(x_{i+1}).$$

Using Lemma 21, we can show that $\mathcal{L}(F) = \mathsf{dom}(C^p_{\vdash F}(q, \varsigma, q'))$ and also that for each $u \in \mathcal{L}(F)$, $[\![C^p_{\vdash F}(q, \varsigma, q')]\!](u)$ is the output produced by $\widetilde{\mathcal{A}}$ on $\widetilde{\vdash u}$ when starting on the right in state q until it exists on the right in state q'.

Lemma 23. Let $F \cdot G^{\omega}$ be an unambiguous rational expression such that F and G are ε -free Tr-good rational expressions and $\operatorname{Tr}(G) = \sigma = (r^p, b^p, s^p)_{p \in P}$ is an idempotent in the transition monoid TrM of $(\mathcal{A}, \mathcal{B})$. We can construct an ω -RTE $C_{FG^{\omega}}$ such that $\operatorname{dom}(C_{FG^{\omega}}) = \mathcal{L}(FG^{\omega}) \cap \operatorname{dom}(\mathcal{A})$ and for each $w \in \operatorname{dom}(C_{FG^{\omega}})$, $\|C_{FG^{\omega}}\|(w) = \|\mathcal{A}\|(w)$.

Proof. We first show that there exists one and only one state $p \in P$ such that $r^p = p$ and $b^p = 1$. For the existence, consider a word $w = u_1u_2u_3\cdots \in \mathcal{L}(FG^\omega)$ with $u_1 \in \mathcal{L}(F)$ and $u_n \in \mathcal{L}(G)$ for all $n \geq 2$. By definition of BDBA there is a unique final run of \mathcal{B} over w: $p_0, u_1, p_1, u_2, p_2, \ldots$. Let us show first that $p_n = p_1$ for all $n \geq 1$. Since σ is idempotent, we have $\operatorname{Tr}(u_2 \cdots u_{n+1}) = \operatorname{Tr}(u_{n+1})$. Since $p_1 \xleftarrow{u_2 \cdots u_{n+1}} p_{n+1}$ and $p_n \xleftarrow{u_{n+1}} p_{n+1}$, we deduce that $p_1 = r^{p_{n+1}} = p_n$. This implies $p_1 = r^{p_2} = r^{p_1}$. Let $p = p_1$ so that $p = r^p$ and the final run of \mathcal{B} on $p_0, p_1, p_2, p_3, p_4, p_5$. Now, for all $p_0 \geq p_1$ we have $\operatorname{Tr}(u_n) = p_0$ and we deduce that $p_0 \neq p_1$ visits a final state from Fin iff $p_0 = p_1$. Since the run is accepting, we deduce that indeed $p_0 = p_1$. To prove the unicity, let $p_0 \in P$ with $p_0 = r^p$ and $p_0 = p_1$. Let $p_0 \in \mathcal{L}(G)$. We have $p_0 \neq p_1$ and this subrun visits a final state from Fin. Therefore, $p_0, p_0, p_0, p_0, p_0, p_0, p_0$. Since $p_0 = p_0$ is BDBA, there is a unique final run of $p_0 = p_0$ on $p_0 = p_0$, which proves the unicity of $p_0 = p_0$.

We apply Lemma 22. We denote by $s'_{\vdash F}$ the set of triples $(q,d,q') \in Q \times \{\rightarrow, \varsigma\} \times Q$ such that the RTE $C^p_{\vdash F}(q,d,q')$ is defined.

Starting from the initial state q_0 of \mathcal{A} , there exists a unique sequence of steps $x_1' = (q_0, \to, q_1')$, $x_2' = (q_1', \supset, X_2', q_2'), \ x_3' = (q_2', \subset, q_3'), \ x_4' = (q_3', \supset, X_4', q_4'), \ \dots, \ x_i' = (q_{i-1}', \subset, q_i'), \ x_{i+1}' = (q_i', \to, X_{i+1}', q) \text{ with } i \geq 1, \ x_1', x_3', \dots, x_i' \in s_{FF}' \text{ and } x_2', x_4', \dots, x_{i+1}' \in s_F''$. We define

$$\begin{split} C_1 &= \left(C^p_{\vdash F}(x_1') \boxdot C^p_G(x_2') \right) \odot \left(C^p_{\vdash F}(x_3') \boxdot C^p_G(x_4') \right) \odot \cdots \odot \left(C^p_{\vdash F}(x_i') \boxdot C^p_G(x_{i+1}') \right) \\ C_2 &= C_1 \boxdot \left(G^\omega ? \varepsilon : \bot \right). \end{split}$$

We have $\mathsf{dom}(C_1) = FG$ and $\widecheck{\vdash} u_1 u_2^p = \widecheck{\vdash} u_1^p \widetilde{u_2}^p$ for all $u_1 \in F$ and $u_2 \in G$. Moreover, $\llbracket C_1 \rrbracket (u_1 u_2)$ is the output produced by $\widetilde{\mathcal{A}}$ on $\widecheck{\vdash} u_1 u_2^p$ when starting on the left in the initial state q_0 until it exists on the right in state q. Now, C_2 is an ω -RTE with $\mathsf{dom}(C_2) = FG^\omega$ and for all $w = u_1 u_2 u_3 \ldots \in FG^\omega$ with $u_1 \in F$ and $u_n \in G$ for all n > 1, we have $\llbracket C_2 \rrbracket (w) = \llbracket C_1 \rrbracket (u_1 u_2) \in \Gamma^*$.

Now, we distinguish two cases. First, assume that there is a step $x=(q,\to,X,q')\in s^p$. Since σ is idempotent, so is s^p , and since $x'_{i+1}=(q'_i,\to,X'_{i+1},q)\in s^p$ we deduce that q'=q. Therefore, the unique run of $\widetilde{\mathcal{A}}$ on $\widetilde{\vdash w}=\widetilde{\vdash u_1}^p\widetilde{u_2}^p\widetilde{u_3}^p\cdots$ follows the steps $x'_1x'_2\cdots x'_ix'_{i+1}xxx\cdots$. Hence, the set of states visited infinitely often along this run is X and the run is accepting iff $X\in\mathcal{F}$ is a Muller set. Therefore, if $X\notin\mathcal{F}$ we have $FG^\omega\cap\operatorname{dom}(\mathcal{A})=\emptyset$ and we set $C_{FG^\omega}=\bot$. Now, if $X\in\mathcal{F}$ we have $FG^\omega\subseteq\operatorname{dom}(\mathcal{A})$ and we set

$$C_{FG^{\omega}} = C_2 \odot \left((FG? \varepsilon : \bot) \boxdot C_G^p(x)^{\omega} \right).$$

We have $dom(C_{FG^{\omega}}) = FG^{\omega}$ and for all $w = u_1u_2u_3... \in FG^{\omega}$ with $u_1 \in F$ and $u_n \in G$ for all n > 1, we have

$$[\![C_{FG^{\omega}}]\!](w) = [\![C_1]\!](u_1u_2)[\![C_G^p(x)]\!](u_3)[\![C_G^p(x)]\!](u_4)\cdots.$$

By (J_2) , we know that for all $n \geq 3$, $[\![C_G^p(x)]\!](u_n)$ is the output produced by $\widetilde{\mathcal{A}}$ when running step $x = (q, \to, X, q)$ on $\widetilde{u_n}^p$. We deduce that $[\![C_{FG^\omega}]\!](w) = [\![\widetilde{\mathcal{A}}]\!](\widetilde{\vdash w}) = [\![\mathcal{A}]\!](w)$ as desired.

The second case is when the unique step $x_1=(q, \searrow, X_1, q_1)$ in s^p which starts from the left in state q exits on the left. Since s^p is idempotent and $x'_{i+1}=(q'_i, \rightarrow, X'_{i+1}, q) \in s^p$, by definition of the product $s^p \cdot s^p$, there is a unique sequence of steps $x_2=(q_1, \subsetneq, X_2, q_2), x_3=(q_2, \searrow, X_3, q_3), \ldots, x_j=(q_{j-1}, \subsetneq, X_j, q_j), x_{j+1}=(q_j, \rightarrow, X_{j+1}, q)$ in s^p with $j\geq 2$. Therefore, for all $w=u_1u_2u_3\ldots\in FG^\omega$ with $u_1\in F$ and $u_n\in G$ for all n>1, the unique run of $\widetilde{\mathcal{A}}$ on $\widetilde{\vdash w}=\widetilde{\vdash u_1}^p\widetilde{u_2}^p\widetilde{u_3}^p\cdots$ follows the steps $x'_1x'_2\cdots x'_ix'_{i+1}(x_1x_2x_3\cdots x_jx_{j+1})^\omega$. Hence, the set of states visited infinitely often along this run is $X=X_1\cup X_2\cup \cdots \cup X_{j+1}$. We deduce that the run is accepting iff $X\in \mathcal{F}$ is a Muller set. Therefore, if $X\notin \mathcal{F}$ we have $FG^\omega\cap \text{dom}(\mathcal{A})=\emptyset$ and we set $C_{FG^\omega}=\bot$. Now, if $X\in \mathcal{F}$ we have $FG^\omega\subseteq \text{dom}(\mathcal{A})$ and we set

$$C_3 = \left((G? \varepsilon : \bot) \boxdot C_G^p(x_1) \right) \odot \left(C_G^p(x_2) \boxdot C_G^p(x_3) \right) \odot \cdots \odot \left(C_G^p(x_j) \boxdot C_G^p(x_{j+1}) \right)$$

$$C_{FG^{\omega}} = C_2 \odot \left((F? \varepsilon : \bot) \boxdot [G, C_3]^{2\omega} \right).$$

We have $dom(C_{FG^{\omega}}) = FG^{\omega}$ and for all $w = u_1u_2u_3... \in FG^{\omega}$ with $u_1 \in F$ and $u_n \in G$ for all n > 1, we have

$$[\![C_{FG^{\omega}}]\!](w) = [\![C_1]\!](u_1u_2)[\![C_3]\!](u_2u_3)[\![C_3]\!](u_3u_4)\cdots.$$

Using (J_2) , we can check that this is the output produced by $\widetilde{\mathcal{A}}$ when running on $\widetilde{+w}$. We deduce that $\llbracket C_{FG^{\omega}} \rrbracket(w) = \llbracket \widetilde{\mathcal{A}} \rrbracket(\widetilde{+w}) = \llbracket \mathcal{A} \rrbracket(w)$ as desired.

We are now ready to prove that ω -2DMTla are no more expressive than ω -RTEs.

Proof of Theorem 13 (2). We use the notations of the previous sections, in particular for the ω -2DMTla \mathcal{A} , the BDBA \mathcal{B} . We apply Theorem 20 to the canonical morphism Tr from Σ^* to the transition monoid TrM of $(\mathcal{A}, \mathcal{B})$. We obtain an unambiguous rational expression $G = \bigcup_{k=1}^m F_k \cdot G_k^\omega$ over Σ such that $\mathcal{L}(G) = \Sigma^\omega$ and for all $1 \leq k \leq m$ the expressions F_k and G_k are ε -free Tr-good rational expressions and σ_{G_k} is an idempotent, where $\text{Tr}(G_k) = \{\sigma_{G_k}\}$. For each $1 \leq k \leq m$, let $C_k = C_{F_k}G_k^\omega$ be the ω -RTE given by Lemma 23. We define the final ω -RTE as

$$C = F_1 G_1^{\omega} ? C_1 : (F_2 G_2^{\omega} ? C_2 : \cdots (F_{m-1} G_{m-1}^{\omega} ? C_{m-1} : C_m)).$$

From Lemma 23, we can easily check that dom(C) = dom(A) and $\llbracket C \rrbracket(w) = \llbracket A \rrbracket(w)$ for all $w \in dom(C)$.

4 Conclusion

The main contribution of the paper is to give a characterisation of regular string transductions using some combinators, giving rise to regular transducer expressions (RTE). Our proof uniformly works well for finite and infinite string transformations. RTE are a succint specification

mechanism for regular transformations just like regular expressions are for regular languages. It is worthwhile to consider extensions of our technique to regular tree transformations, or in other settings where more involved primitives such as sorting or counting are needed. The minimality of our combinators in achieving expressive completeness, as well as computing complexity measures for the conversion between RTEs and two-way transducers are open.

Α **Examples**

More details on the Example in the Introduction

We continue with the computation of the RTE $C_{E_3}(q_0, \to, q_2)$ for $E_3 = [(ba^+)^3]^+b \subseteq \mathsf{dom}(\mathcal{A})$. This involves the use of the 2-chained Kleene-plus




Figure 10 run of a word in $E_3 = [(ba^+)^3]^+ b$

We want to compute the RTE for the step (q_0, \rightarrow, q_2) on a word $u \in E_3$. It can be decomposed as shown in Figure 10. Unlike the case of E_2 , we have to use the 2-chained Kleene plus. Let $F = (ba^+)^3$ so that $E_3 = F^+b$. We have (see Figure 10),

$$C_{E_3}(q_0,\to,q_2) = (C_{F^+}(q_0,\to,q_3) \boxdot C_b(q_3,\searrow,q_4)) \odot (C_{F^+}(q_4, \swarrow,q_1) \boxdot C_b(q_1,\to,q_2)).$$

We know that $C_b(q_3, \triangleright, q_4) = (b/\varepsilon) = C_b(q_1, \rightarrow, q_2)$ hence it remains to compute $C_{F^+}(q_0, \rightarrow, q_3)$ and $C_{F+}(q_4, \leq, q_1)$. First we define RTEs associated with atomic expressions and steps which are going to be used in constructing $C_{E_3}(q_0, \rightarrow, q_2)$. They are $C_b(q_3, \supset, q_4) = C_b(q_6, \rightarrow, q_1) =$ $C_b(q_1, \to, q_2) = C_b(q_5, \to, q_6) = (b/\varepsilon) \text{ and } C_{a^+}(q_2, \to, q_3) = C_{a^+}(q_1, \to, q_1) = (a/\varepsilon)^{\boxplus}, C_{a^+}(q_4, \to, q_4) = (a/\varepsilon)^{\boxplus}$ $,q_4)=(a/a)^{\stackrel{\longleftarrow}{\boxplus}},\ C_{a^+}(q_5,\leftarrow,q_5)=(a/b)^{\stackrel{\longleftarrow}{\boxplus}}.$ We compute RTE $C_F(x)$ for the relevant steps x in the monoid element X = Tr(F). F is an unambiguous catenation of $E_2 = ba^+ba^+b$ with a^+ and from Figure 2, it can be seen that:

1. For $y_1 = (q_0, \to, q_3)$

$$C_{F}(y_{1}) = C_{E_{2}}(q_{0}, \rightarrow, q_{2}) \odot C_{a^{+}}(q_{2}, \rightarrow, q_{3})$$

$$= \left((b/\varepsilon) \overleftarrow{\odot} (a/b) \overleftarrow{\boxtimes} (b/\varepsilon) \overleftarrow{\odot} (a/a) \overleftarrow{\boxminus} \right) \odot (b/\varepsilon) \odot (a/\varepsilon)^{\boxplus}$$

where $C_{E_2}(q_0, \rightarrow, q_2)$ has been computed in Section 1. For example, $[C_F(y_1)](ba^{m_1}ba^{m_2}ba^{m_3}) = a^{m_2}b^{m_1}$.

2. Continuing with the computation for $(ba^+)^3$ as in Figure 10, for $y_2 = (q_3, \geq, q_4)$, we take the Cauchy product of $C_b(q_3, \ge, q_4)$ with $(a^+ba^+ba^+?\varepsilon:\bot)$.

$$C_F(y_2) = C_b(q_3, \triangleright, q_4) \boxdot (a^+ba^+ba^+?\varepsilon:\bot) \approx ((ba^+)^3?\varepsilon:\bot)$$
$$[C_F(y_2)](ba^{m_1}ba^{m_2}ba^{m_3}) = \varepsilon.$$

3. For $y_3 = (q_4, \leq, q_1)$, we have

$$C_{F}(y_{3}) = (ba^{+}?\varepsilon:\bot) \stackrel{\leftarrow}{\boxdot} C_{ba^{+}ba^{+}}(y_{3})$$

$$= (ba^{+}?\varepsilon:\bot) \stackrel{\leftarrow}{\boxdot} ((b/\varepsilon) \stackrel{\leftarrow}{\boxdot} (a/b) \stackrel{\rightleftharpoons}{\boxminus} \stackrel{\leftarrow}{\smile} (b/\varepsilon) \stackrel{\leftarrow}{\smile} (a/a) \stackrel{\rightleftharpoons}{\boxminus})$$

$$\approx (ba^{+}b?\varepsilon:\bot) \stackrel{\frown}{\smile} ((a/b) \stackrel{\rightleftharpoons}{\boxminus} \stackrel{\leftarrow}{\smile} (b/\varepsilon) \stackrel{\leftarrow}{\smile} (a/a) \stackrel{\rightleftharpoons}{)}$$

where $C_{ba+ba+}(y_3)$ is already computed in Section 1.

As an example, $[C_F(y_3)](ba^{m_1}ba^{m_2}ba^{m_3}) = a^{m_3}b^{m_2}$.

4. For $y_4 = (q_1, \geq, q_5)$, it is similar to the $C_E(y)$ computed for C_{E_2} in Section 1. Here we have

$$C_{F}(y_{4}) = C_{ba+b}(y_{4}) \boxdot (a^{+}ba^{+}?\varepsilon:\bot)$$

$$= ((C_{b}(q_{1}, \rightarrow, q_{2}) \boxdot C_{a+}(q_{2}, \rightarrow, q_{3}) \boxdot (b/\varepsilon)) \odot$$

$$(C_{b}(q_{4}, \leftarrow, q_{5}) \overleftarrow{\boxdot} C_{a+}(q_{4}, \leftarrow, q_{4}) \overleftarrow{\boxdot} C_{b}(q_{3}, \triangleright, q_{4}))) \boxdot (a^{+}ba^{+}?\varepsilon:\bot)$$

$$= (((b/\varepsilon) \boxdot (a/\varepsilon)^{\boxplus} \boxdot (b/\varepsilon)) \odot ((b/\varepsilon) \overleftarrow{\boxdot} (a/a)^{\overleftarrow{\boxminus}} \overleftarrow{\boxdot} (b/\varepsilon))) \boxdot (a^{+}ba^{+}?\varepsilon:\bot)$$

$$\approx ((b/\varepsilon) \overleftarrow{\boxdot} (a/a)^{\overleftarrow{\boxminus}} \overleftarrow{\boxdot} (b/\varepsilon)) \boxdot (a^{+}ba^{+}?\varepsilon:\bot)$$

As an example, $[C_F(y_4)](ba^{m_1}ba^{m_2}ba^{m_3}) = a^{m_1}$.

5. For $y_5 = (q_5, \zeta, q_6)$, in the computation of $C_F(y_5)$ we need $C_{ba^+}(y_5)$. Thus, we compute $C_{ba^+}(y_5)$ below whose computation is similar to $C_E(y)$ computed in Section 1.

$$C_{ba^{+}}(y_{5}) = ((b/\varepsilon) \stackrel{\leftarrow}{\boxdot} C_{a^{+}}(q_{5}, \leftarrow, q_{5})) \odot (C_{b}(q_{5}, \rightarrow, q_{6}) \boxdot C_{a^{+}}(q_{6}, \rightarrow, q_{6}))$$
$$= ((b/\varepsilon) \stackrel{\leftarrow}{\boxdot} (a/b) \stackrel{\rightleftharpoons}{\boxminus}) \odot ((b/\varepsilon) \boxdot (a/\varepsilon)^{\boxminus}) \approx (b/\varepsilon) \stackrel{\leftarrow}{\boxdot} (a/b) \stackrel{\rightleftharpoons}{\boxminus}$$

We can compute $C_F(y_5)$ as

$$C_F(y_5) = (ba^+ba^+?\varepsilon:\bot) \boxdot C_{ba^+}(y_5) \approx (ba^+ba^+b?\varepsilon:\bot) \overleftarrow{\boxdot} (a/b)^{\overleftarrow{\boxminus}}$$

As an example, $[C_F(y_5)](ba^{m_1}ba^{m_2}ba^{m_3}) = b^{m_3}$.

6. For $y_6 = (q_6, \rightarrow, q_3)$, the computation of $C_F(y_6)$ is similar to $C_{ba+ba+}(q_0, \rightarrow, q_2)$ in Section 1. We need $C_{ba+ba+}(q_6, \rightarrow, q_3)$ and $C_{ba+ba+b}(q_6, \rightarrow, q_2)$. We see the computation of these below step by step.

$$\begin{split} C_{ba^+ba^+}(q_6,\to,q_3) &= C_b(q_6,\to,q_1) \boxdot C_{a^+}(q_1,\to,q_1) \boxdot C_b(q_1,\to,q_2) \boxdot C_{a^+}(q_2,\to,q_3) \\ &= (b/\varepsilon) \boxdot (a/\varepsilon)^{\boxplus} \boxdot (b/\varepsilon) \boxdot (a/\varepsilon)^{\boxplus} \approx (ba^+ba^+\,?\,\varepsilon:\bot) \\ C_{ba^+ba^+b}(q_6,\to,q_2) &= (C_{ba^+ba^+}(q_6,\to,q_3) \boxdot C_b(q_3,\rhd,q_4)) \odot (C_{ba^+ba^+}(q_4,\varsigma,q_1) \boxdot C_b(q_1,\to,q_2)) \\ &\approx (ba^+ba^+b\,?\,\varepsilon:\bot) \odot (((b/\varepsilon) \overleftarrow{\boxdot} (a/b)^{\overleftarrow{\boxminus}} \overleftarrow{\boxdot} (b/\varepsilon) \overleftarrow{\boxdot} (a/a)^{\overleftarrow{\boxminus}}) \boxdot (b/\varepsilon)) \\ &\approx \left((b/\varepsilon) \overleftarrow{\boxdot} (a/b)^{\overleftarrow{\boxminus}} \overleftarrow{\boxdot} (b/\varepsilon) \overleftarrow{\boxdot} (a/a)^{\overleftarrow{\boxminus}}\right) \boxdot (b/\varepsilon) \end{split}$$

Note that $C_{ba+ba+}(q_4, \leq, q_1)$ has been computed in Section 1. Now we concatenate with $C_{a+}(q_2, \rightarrow, q_3)$ needed in the computation.

$$C_{F}(y_{6}) = C_{ba+ba+b}(q_{6}, \rightarrow, q_{2}) \odot C_{a+}(q_{2}, \rightarrow, q_{3})$$

$$= ((b/\varepsilon) \overleftarrow{\odot} (a/b) \overleftarrow{\boxtimes} \overleftarrow{\odot} (b/\varepsilon) \overleftarrow{\odot} (a/a) \overleftarrow{\boxminus}) \odot (b/\varepsilon) \odot (a/\varepsilon^{\boxminus})$$

$$\approx ((b/\varepsilon) \overleftarrow{\odot} (a/b) \overleftarrow{\boxtimes} \overleftarrow{\odot} (b/\varepsilon) \overleftarrow{\odot} (a/a) \overleftarrow{\boxminus}) \odot (ba^{+}?\varepsilon: \bot)$$

As an example, $[C_F(y_6)](ba^{m_1}ba^{m_2}ba^{m_3}) = a^{m_2}b^{m_1}$.

Now we are in a position to compute RTE $C_{F^+}(q_0, \rightarrow, q_3)$. As shown in figure 10, it is a concatenation of step y_1 and then steps y_2 , y_3 , y_4 , y_5 and y_6 repetitively. Consecutive pairs of $(ba^+)^3$ are needed to compute the RTE and thanks to the 2-chained Kleene plus, we can define the RTE for the same.

$$C_{F^+}(y_1) = (C_F(y_1) \boxdot (F^*?\varepsilon:\bot)) \odot [F,C']^{2\boxplus}$$

$$C' = ((F?\varepsilon:\bot) \boxdot C_F(y_2)) \odot (C_F(y_3) \boxdot C_F(y_4)) \odot (C_F(y_5) \boxdot C_F(y_6))$$

As an example, $[C_{F^+}(y_1)](ba^{m_1}ba^{m_2}ba^{m_3}ba^{m_4}ba^{m_5}ba^{m_6}) = a^{m_2}b^{m_1}a^{m_3}b^{m_2}a^{m_4}b^{m_3}a^{m_5}b^{m_4}$.

Finally, we compute RTE for $y=(q_0,\rightarrow,q_2)$ for the expression $E_3=[(ba^+)^3]^+b$ by concatenating b with the above RTE.

$$C_{E_3}(y) = (C_{F^+}(q_0, \to, q_3) \boxdot C_b(q_3, \searrow, q_4)) \odot (C_{F^+}(q_4, \subsetneq, q_1) \boxdot C_b(q_1, \to, q_2))$$

Notice that $C_{F^+}(q_4, \zeta, q_1) = (F^*? \varepsilon : \bot) \boxdot C_F(y_3)$.

We have already seen that $C_{E_3}(y)$ computes the output produced by a successful run on a word $w \in E_3$. Applying the RTE as above, we have, for example,

A.2 A Motivating Example

Apart from theoretical interest, regular expressions have great practical utility, being used in search engines, or in search and replace patterns in text processors, or in lexical analysis in compilers. Many programming languages like Java and Python also support regular expressions using a regexp engine, as part of their standard libraries. We believe that our extension of the beautiful theory of regular expressions to regular transducer expressions over both finite and infinite words has many useful applications.

As a specific example, we consider the dmesg command (see Figure 11 for a sample output) used to write the kernel messages in Linux and other Unix-like operating systems to standard output (which by default is the display screen). The output is often captured in a permanent system logfile via a logging daemon, such as syslog. The kernel is the first part of the operating system that is loaded into memory when a computer boots up. The numerous messages generated by the kernel that appear on the display screen as a computer boots up show the hardware devices that the kernel detects and indicate whether it is able to configure them. dmesg obtains its data by reading the kernel ring buffer, a portion of a computer's memory that is set aside as a temporary holding place for data that is being sent to or received from an external device, such as a hard disk drive (HDD), printer or keyboard. Using dmesg along with the -w option gives real time updates while the -xH option provides extra information with each line of the kernel message relating to various (external) devices. This information can be one of err (for error), emerg (for emergency), warn (for warning), info (for information) and so on. dmesg can thus be very useful when troubleshooting or just trying to obtain information about the hardware on a system by analyzing this output. We can extract from the output produced by dmesg some messages with contextual information. For instance, if we are searching for err messages, and wish to resolve them, we need some contextual information, like 10 lines before and 10 lines after the message. This is a regular transformation which can be specified with an ω -RTE and implemented with a two-way transducer as described below. It takes as input the (unbounded) log produced by dmesg – wHx and produces as output lines containing err messages with their contexts.

A.2.1 Detecting context of error in dmesg

In this section, we give details of how the errors in dmesg command are detected and their context is given as output using ω -RTEs or transducers.

A.2.2 An ω -RTE for dmesg

We first give an ω -RTE which analyzes the output of dmesg, and produces the appropriate contexts. The RTE is a specification language which is easier to understand than the transducer which describes the same computation.

The required ω -RTE inspects the output of dmesg, and if it detects a line containing the message err, then it outputs 10 lines before this line, 10 lines after this line as the necessary context needed to investigate the reason for the error. This is done for all lines containing err.

The ω -RTE is broken into two parts. We first look at the first 10 lines of the file. If any of these lines (say line i) has err, we output the lines $1, \ldots, i+10$.

- 1. Let \n denotes newline, $\operatorname{char} = \Sigma \setminus \{ \setminus n \}$, $\operatorname{line} = \operatorname{char}^+ \cdot \setminus n$ and $\operatorname{err}_i = \operatorname{line}^i \cdot \operatorname{char}^7 \cdot \operatorname{err} \cdot \Sigma^\omega$ be an expression which says that there is an "err" in the i+1th line for $i \geq 0$. The message starts from the 8th character on each line, so we scan from the 8th character for err.
- 2. Let $C_i = \text{err}_i$? [(lineⁱ⁺¹¹?copy: \bot) \boxdot (line^{ω}? ε : \bot)]: ε be an ω -RTE which gives the context of the error if the error is found in the (i+1)th line where $0 \le i \le 9$. The RTE copy defines the identity function on Σ^+ : For instance, if $\Sigma = \{a, b, c\}$ then copy = a? a: (b?b: (c?c: \bot)) $^{\boxplus}$. Thus, if there is an "err" in the first 10 lines, the context is generated using C_i .
- 3. To catch occurrences of "err" in lines 11 and later in the file, we use $[\lim, C']^{21\omega}$, the 21-chained ω -iteration. Here, C' is an RTE which copies the context for each line containing "err" starting from line number 11:

4. The required ω -RTE $C = C_0 \odot C_1 \odot \cdots \odot C_9 \odot [\mathsf{line}, C']^{21\omega}$.

Thus, the first 10 lines are checked for "err" and the respective context is output if a line $0 \le i < 10$ has "err"; the remaining lines in the file are treated using the $[K, C']^{21\omega}$, where we look at blocks of 21 lines, and reproduce them as is, if the 11th line in the block has an "err"; this is repeated from the next line and so on. The $[K, C']^{21\omega}$ is not a new combinator, it can be written in terms of 2-chained ω -iteration as shown by Lemma 24.

A.2.3 Machine description for dmesg

Now we describe a transducer that produces the contexts based on the output of dmesg. Since the dmesg command continuously monitors not only external devices, but also the RAM, processors, cache and the hard disk, the output is continuously updated in real time. Hence, the output is arbitrarily long.

The transducer \mathcal{A} takes as input, the output as generated above, and needs the two way functionality. We do not use the look-ahead option here. Whenever \mathcal{A} reads a line containing "err", it goes back 10 lines (or $i \leq 10$ lines, if there are only i < 10 lines before the current line), and outputs the next 21 lines (or 11+i lines). Then it goes back 10 lines to check the message in the next line. The transducer \mathcal{A} can be obtained inductively from the ω -RTE C described above, or it can be directly constructed. Because it has to count up to 10 several times, the automaton is rather large, but it can be constructed easily.

A.2.4 Reducing k-chained ω -iteration to 2-chained ω -iteration for k > 2

Lemma 24. For k > 2, the RTE $[L, f]^{k\omega}$ can be derived from RTEs defined in Section 3.2.

Proof. Let $L \subseteq \Sigma^+$ be a regular language, let $f: \Sigma^+ \to \mathbb{D}$ and let $g = [L, f]^{k\omega}$. First, recall that by definition, g(w) is defined as $f(u_1u_2 \cdots u_k) \cdot f(u_2u_3 \cdots u_{k+1}) \cdot f(u_3u_4 \cdots u_{k+2}) \cdots$ iff w admits a unique factorization $w = u_1u_2u_3 \cdots$ with each $u_i \in L$ for $i \geq 1$.

For n > 0, we let L_n be the set of words w which admit a unique factorization $w = u_1 u_2 \cdots u_n$ with each $u_i \in L$ for $1 \le i \le n$. Notice that $L_n \subseteq L^n \subseteq \Sigma^+$ is a regular language. We also define L_{ω} as the set of words $w \in \Sigma^{\omega}$ which admit a unique factorization $w = u_1 u_2 u_3 \cdots$ with $u_i \in L$ for all $i \ge 1$. Indeed, $L_{\omega} \subseteq L^{\omega}$ is an ω -regular language.

We define by induction for $n \geq 0$ a function f_n such that $\mathsf{dom}(f_n) \subseteq L_{k+n}$ and if $w = u_1 u_2 \cdots u_{k+n}$ is the unique factorization of w with $u_i \in L$ for $1 \leq i \leq k+n$ then

$$f_n(w) = f(u_1 u_2 \cdots u_k) f(u_2 u_3 \cdots u_{k+1}) \cdots f(u_{n+1} u_{n+2} \cdots u_{n+k}).$$

We let $f_0 = L_k ? f : \bot$ and for n > 0 we define $f_n = (f_{n-1} \boxdot (L?\varepsilon : \bot)) \odot ((L_n?\varepsilon : \bot) \boxdot f_0)$. Note that this gives us $f_1 = (f_0 \boxdot (L?\varepsilon : \bot)) \odot ((L?\varepsilon : \bot) \boxdot f_0)$, which works on strings of length k+1, and produces $f(u_1 \cdots u_k) f(u_2 \cdots u_{k+1})$. Likewise, $f_2 = (f_1 \boxdot (L?\varepsilon : \bot)) \odot ((L_2?\varepsilon : \bot) \boxdot f_0)$, which works on strings of length k+2, and produces $f_1(u_1 \cdots u_{k+1}) f(u_3 \cdots u_{k+2})$, which in turn expands to $f(u_1 \cdots u_k) f(u_2 \cdots u_{k+1}) f(u_3 \cdots u_{k+2})$.

Finally, let $h = L_{\omega} ? [L_k, f']^{2\omega} : \bot$ with $f' = f_{k-1} \boxdot (L?\varepsilon : \bot)$. Notice that $\mathsf{dom}(f') \subseteq L_{2k}$. We claim that g(w) = h(w) for all $w \in \Sigma^{\omega}$.

Let $w \in L_{\omega} \supseteq \text{dom}(g) \cup \text{dom}(h)$. Consider the unique factorization $w = u_1 u_2 u_3 \cdots$ with $u_i \in L$ for all $i \ge 1$. For all $i \ge 1$, let $w_i = u_{(i-1)k+1} \cdots u_{ik}$. Clearly, $w = w_1 w_2 w_3 \cdots$ is the unique factorization of w with $w_i \in L_k$ for all $i \ge 1$. Now, $h(w) = f'(w_1 w_2) f'(w_2 w_3) \cdots$ and for each $i \ge 1$ we have

$$f'(w_i w_{i+1}) = f(u_{(i-1)k+1} \cdots u_{ik}) f(u_{(i-1)k+2} \cdots u_{ik+1}) \cdots f(u_{ik} \cdots u_{ik+k-1}).$$

We deduce that h(w) = g(w).

Example 25. Let k=4. We have $g=[L,f]^{4\omega}=L_{\omega}\,?\,[L_4,f']^{2\omega}:\bot$ by lemma 24. We show the computation of $[L,f]^{4\omega}$ on a word $w\in L_{\omega}$ using this new RTE. Consider the unique factorization $w=u_1u_2u_3\cdots$ with $u_i\in L$ for all $i\geq 1$. Also, let $w_1=u_1\cdots u_4,\ w_2=u_5\cdots u_8$ and so on. We have $w_i\in L_4$ for all $i\geq 1$. Now,

 and $[L_4, f']^{2\omega}(w) = f'(u_1 \cdots u_8) f'(u_5 \cdots u_{12}) \cdots$




Figure 12 Computation of $f'(u_1 \cdots u_8)$

Lemma 26. Similar to lemma 24, the RTE $[L, f]^{k \boxplus}$ can be derived from RTEs defined in Section 2.2 for k > 2.

Proof. The proof technique is similar to Lemma 24. Definitions of L_n, f_n, f' are as defined in this lemma. In addition we use L_+ , the set of words having a unique decomposition $w = u_1 u_2 \cdots u_n$ with $n \geq 1$ and $u_i \in L$ for all $1 \leq i \leq n$. We also use $L_{< k} = L_0 \cup L_1 \cup \cdots \cup L_{k-1}$, where $L_0 = \{\varepsilon\}$. We define

$$h = L_{+}? [([L_{k}, f']^{2 \boxplus} \boxdot (L_{< k}? \varepsilon : \bot)) \odot ((L_{k}^{*}? \varepsilon : \bot) \boxdot h')] : \bot$$

$$h' = L_{k}? f : (L_{k+1}? f_{1} : (L_{k+2}? f_{2} : (\cdots (L_{2k-1}? f_{k-1} : \bot) \cdots))).$$

We can show as in Lemma 24 that $h = [L, f]^{k \boxplus}$.

B Equivalence of Models

In this section, we look at the equivalence of the automata models for regular transformations on infinite words. The model used here is a two-way, deterministic Muller automaton, which has for each pair (q, a) consisting of a state and symbol, a tuple of look-ahead ω -regular languages

which are mutually exclusive. The model (denoted 2WSTla) used in [4] however is a two-way deterministic Muller automaton which is equipped with a look-behind automaton (a NFA) and a look-ahead automaton (a possibly non-deterministic Muller automaton). Here, we show that these two models are equivalent in expressiveness.

Lemma 27. ω -2DMTIa and 2WSTIa (defined in [4]) are equivalent representations for ω -regular transformations.

- **Proof sketch.**(\subseteq) Given an ω -2DMTla $\mathcal{A}=(Q,\Sigma,\Gamma,q_0,\delta,\mathcal{F},\mathcal{R})$, one can construct a 2WSTla \mathcal{A}' such that $[\![\mathcal{A}]\!]=[\![\mathcal{A}']\!]$. We create a look ahead automata A_L as the disjoint union of all $\mathcal{A}_i=(Q_i,\Sigma,s_i,\delta_i,\mathcal{F}_i)$ corresponding to each look ahead language R_i in \mathcal{R} : $\mathcal{L}(\mathcal{A}_i)=R_i$. The set of states of the 2WSTla \mathcal{A}' is Q, with initial state q_0 and Muller accepting set \mathcal{F} . The transition function δ' of \mathcal{A}' is defined by $\delta'(q,a,\Sigma^*,s_i)=(q',\gamma,d)$, if $\delta(q,(a,R_i))=(q',\gamma,d)$. Note that since we do not use any look-behind in \mathcal{A} , the look-behind automaton needed for the model in [4] is the trivial one which accepts all strings. Rather than writing the single state look-behind automaton (where the state is both accepting and initial), we write the expression Σ^* .
- (\supseteq) Given 2WSTla $\mathcal{T} = ((Q, \Sigma, \Gamma, \delta, q_0, \mathcal{F}), \mathcal{A}, \mathcal{B})$ with look-ahead automata $\mathcal{A} = (Q_A, \Sigma, \delta_A, \mathcal{F}_A)$ and look-behind automata $\mathcal{B} = (Q_B, \Sigma, \delta_B, F_B)$, one can construct an ω -2DMTla $\mathcal{A}' = (Q', \Sigma, \Gamma, q'_0, \delta', \mathcal{F}', \mathcal{R})$ such that $\llbracket \mathcal{T} \rrbracket = \llbracket \mathcal{A}' \rrbracket$. For each state $p \in Q_B$ we let $K_p \subseteq \Sigma^*$ be the regular languages accepted by \mathcal{B} with initial state p. Similarly, for each state $p \in Q_A$ we let $L_p \subseteq \Sigma^\omega$ be the ω -regular languages accepted by \mathcal{A} with initial state p. From the determinism of \mathcal{T} we deduce that the languages $(K_p)_{p \in Q_B}$ are mutually exclusive, and similarly the languages $(L_p)_{p \in Q_A}$ are mutually exclusive.

Now, a transition $\delta(q,(s_B,a,s_A))=(q',\gamma,d)$ of \mathcal{T} can be replaced with the more abstract $\delta'(q,(K_{s_B},a,L_{s_A}))=(q',\gamma,d)$ using regular languages instead of states for look-ahead and look-behind. In order to obtain the ω -2DMTla it remains to remove the look-behind.

Consider a DFA $\mathcal{D}=(Q_D,\Sigma,\delta_D,s_D,(F_p)_{p\in Q_B})$ which simultaneously recognizes all the $(K_p)_{p\in Q_B}$: K_p is the set of words accepted by \mathcal{D} when using F_p as set of final states. We define \mathcal{A}' as the synchronized product of \mathcal{T} and \mathcal{D} . More precisely, we let $Q'=Q\times Q_D, q_0'=(q_0,s_D),$ $\mathcal{R}=\{L_{s_A}\mid s_A\in Q_A\}, \mathcal{F}'$ consists of all $X\subseteq Q'$ such that the projection of X on Q belongs to \mathcal{F} . The transition function δ' is defined as follow. If $\delta(q,(s_B,a,s_A))=(q',\gamma,d)$ is a transition of \mathcal{T} , then $\delta'((q,p),(a,L_{s_A}))=((q',p'),\gamma,d)$ is a transition of \mathcal{A}' provided

- $p \in F_{s_B}$, i.e., the prefix read so far belongs to K_{s_B} , or equivalently, is recognized by the look-behind automaton \mathcal{B} when starting from state s_B ,
- $p' = \delta_D(p, a)$ if the transition moves forward (d = +1),
- and if the transition moves backward (d = -1) then p' is obtained form p using the reverse-run algorithm of Hopcroft and Ullman.
